**Assumption of the Risk and Waiver of Liability Relating to Coronavirus/COVID-19**

On my behalf/and or on behalf of my children, I hereby release, covenant not to sue, discharge, and hold harmless the Arena, its employees, agents, and representatives, of and from the Claims, including all liabilities, claims, actions, damages, costs or expenses of any kind arising out of or relating thereto. I understand and agree that this release includes any Claims based on the actions, omissions, or negligence of the Arena, its employees, agents, and representatives, whether a COVID-19 infection occurs before, during, or after participation in any Arena program.
