RELEASE AND WAIVER OF LIABILITY, ASSUMPTION OF RISK, AND INDEMNITY AND PARENTAL CONSENT AGREEMENT
(“AGREEMENT”)

IN CONSIDERATION of being permitted to participate in any way in **STRATMAN SPORTS LLC AND ST. LOUIS SPORTS PARTNERSHIP LLC** activity (“Activity”) I, for myself, for personal representatives, assigned heirs, and next of kin:

ACKNOWLEDGE, agree, and represent that I understand the nature of **STRATMAN SPORTS LLC AND ST. LOUIS SPORTS PARTNERSHIP LLC** Activities and that I am qualified, in good health, and in proper physical condition to participate in such Activity. I further agree and warrant that if at any time I believe conditions to be unsafe, I will immediately discontinue further participation in the Activity.

FULLY UNDERSTAND THAT: (a) **STRATMAN SPORTS LLC AND ST. MINOR RELEASE (For Participants under age of 18):
