Rental Agreement

The undersigned parent/legal guardian understands and accepts the fact that sports participation, including lacrosse, involves risks of injury and bodily harm, including, but not limited to, paralysis and death. These risks are voluntarily and knowingly assumed by the undersigned parent/legal guardian in connection with his or her use of Patriot Lacrosse rental equipment.

The undersigned does hereby unconditionally and forever release and indemnify, and agree to defend and hold harmless, Patriot Lacrosse, together with its board members, members, coaches, and affiliates from and against any and all claims for personal injury (including death), property damage or any other claim, cause of action, damage or liability (including, but not limited to attorneys' fees and litigation expenses) resulting from or arising out of the undersigned player's participation in the sport of lacrosse and/or use of Patriot Lacrosse rental equipment.

The equipment is accepted by the undersigned "AS IS", together with all faults. Patriot Lacrosse makes no representations or warranties of any kind as to the rental equipment. The undersigned acknowledges his or her responsibility to return damaged equipment to the Patriot Lacrosse equipment manager as soon as damage is identified. If an equipment item is damaged beyond normal wear and tear or is lost, the undersigned acknowledges his or her responsibility to replace the item at current retail costs. All rental equipment shall be returned at designated times after the season ends or after post season tournament play. The undersigned is responsible for notifying the equipment manager if equipment will be used in post season tournament play. **If the undersigned cannot attend designated equipment return dates, the undersigned acknowledges his or her responsibility to make arrangements with the Patriot Lacrosse equipment manager to return the equipment.** Patriot Lacrosse will deposit all deposit checks for rental equipment not returned within 1 week of the appropriate return date. Failure to return rental equipment and/or pay for equipment as agreed to may result in the loss of player's ability to register with Patriot Lacrosse Club.

The undersigned parent/legal guardian hereby agrees that he or she has received the referenced equipment below and agrees to be bound by the terms and conditions of this Rental Agreement.
