Purpose:

The Corporation is organized exclusively for charitable, religious, educational, scientific, literary, testing for public safety, fostering national or international amateur sports competition, and preventing cruelty to children or animals purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code of 1986 (or the corresponding provision of any future United States Internal Revenue Law), including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under Section 501(c)(3) of the Internal Revenue Code of 1986 (or the corresponding provision of any future United States Internal Revenue Law). To the extent allowed under the preceding sentence, the Corporation is organized primarily to foster and promote national amateur sports competition among youth and to raise funds for distribution to organizations that qualify as exempt organizations under section 501(c)(3) of the Internal Revenue Code or corresponding section of any future federal tax code.

Achievements

1. The primary activity of the Colleyville Lacrosse Association, and essentially its only activity, is the promotion and development of elementary school lacrosse, middle school lacrosse and high school lacrosse for boys and girls in the Grapevine-Colleyville area by establishing teams coached to develop sport skills, sportsmanship and life skills. It is operated by a board, officers, coaches and other parents who are all volunteers, although a few of the coaches are compensated. The organization is based in Colleyville, Texas and primarily serves students in the Grapevine Colleyville Independent School District although students from other nearby communities are allowed to participate in certain circumstances – such as when their community does not have a team. Our purpose is to develop competitive lacrosse as a primary and secondary school age student sport as more fully described in our organizational documents provided with our original application. 100% of our activities are focused on individual, team and organizational development of lacrosse as a primary and secondary school sport in our area and necessary related activities.

Primary funding is through membership fees and we are planning a Gala in 2010 to defray costs to participate. The organization's funds are used to pay for equipment, fields, facilities, coach compensation, uniforms, and other necessary expenses of lacrosse association. Fees are established based on operational expenses and numbers of players at each respective age-group level. Fees for Spring 2010 season were estimated to cover costs of participation. \$700 per varsity player was estimated to cover costs of participation.

Requirements to participate are registration, payment of fees, use of all required protective equipment, adherence to team sportsmanship rules and regular attendance at practice.

The competitive season in this area is in the Spring but the organization conducts clinics and outreach activities year-round.

As for typical "team activity" teams usually begin practice for the Spring Season in January and will practice two to three times a week as field and coach availability permits. Competitive play with other

teams within the Dallas/Fort Worth area and around the State of Texas begins in late January for high school players and in February or March for the younger players. All continue into May. We expect to field a competitive Division 3 high school lacrosse team this year and to achieve Division 1 status in future years as the youth program develops.

As we have begun our organization, 2009 reporting reflects the startup activities of registering 34 varsity boys for Fall 2009 and Spring 2010 activities. 2010 will reflect an additional 14 girls varsity and 63 youth boys.
