    - i. Nothing new to report. Going into the spring with the board's approval we will use the same fundraising website as before. I have two recommendations.
    - 1. Of the \$15,100 we raised less than 10% was for pledges that were tied to a hit. The way we did it the rest were flat donations. Suggestion... that makes it not worth the effort of trying to schedule a big event, get volunteers, etc. that in two of the last three years has been rained (or snowed) out..

**Recommendation 1**—Do not hold a one day event. Contact coaches that have pledges based on hits and use the last part of a practice to record distances.

2. We had way too many teams that did not participate at all last year. Participation requires very little from a team and manager. Literally all the manager and area rep need to do is to send the link provided.

**Recommendation 2**—Make this a requirement upon selection as a manager. The manager must send the note out.
