➤ MINUTES REVIEW & APPROVAL

- January 2016 minutes reviewed and approved.

➤ TREASURER'S REPORT

- Budget worked on with coach Pees and handed up
- Paid for Glazier coaching clinic
- Cash on hand in account @ the same as last month
- @\$3500 will be moved from player operating account – from non-returning seniors
- Money in from GMJFA and deposited today
- Budget – coach did not put in 1 desired item – end zone camera (\$4000) we don't have to share that film with other teams possibly rent it out the nights we don't have games?
- Nothing put in budget for corporate sponsorships
- Budget approved by majority vote
- Kelly Morse will do taxes and charge us \$75

➤ COACHES REPORT

- New uniforms should come in under 20 K – meeting with Under Armour next week
- Hired defensive coordinator yesterday – Jesse German – from Texas and has been assistant coach of state titlist team – has coached at BC and Heritage
- All dates finalized – UNC official for team camp – facilities there are newer and we get film on each game – minimum 12 teams there when we are there or we will pull out – June 12-14 then off until July 5th
- Finalized 7 v 7 dates – merging with Heritage – Monday nights under the lights – 4 games for sure in July
- Freshman night April 14 at GM commons – Colette will take care of pizza and Bridget dessert and drinks
- 4th Quarter Program – Feb 29- May 27 – Mondays speed, Wednesdays power, Fridays agility -80% participation expected (about 7 can be missed), Spring Break off
- Summer workouts – 80% participation expected M-Th – boys will get schedule for this next week

- Combine done in next 2 weeks to get baseline – 40, squat, bench, shuttle
- Cale will be video coordinator and will travel with the team

➤ NEW BUSINESS/ FUND RAISING

- Poker Tournament – possibly at West Rail – ask Dan Bettis for assistance
- Beth and Patty will handle team dinners next year
- Bridget will do programs, picnic and banquet
- Picnic – possibly Thursday night because our scrimmage is at Skyline and trying to get for Friday

➤ WEBSITE INFO

- Voice Media Group – 1st year \$1500 then \$10/yr – this will be their first team website and they are trying to get into that market – thinking of changing because they can give us a new design, same functionality, ease off access and for 1st year improve SEO (search engine optimization), hopefully get us tied more to social media – eventually would like to sell ad space to GM businesses
- League Athletics (current website) – we may be able to use info from new company as leverage because they may think we are leaving – will compare both to see which makes the most sense
- Possibly have students intern in taking care of website
