MINUTES REVIEW / APPROVAL

Minutes reviewed and approved. Meeting started promptly at 6pm.

TREASURERS REPORT / Ronda Wisor

Ronda not in attendance. Printed reports for current balances were provided via email file.

WEBMASTER/COMMUNICATION REPORT / Janna Goltart

- Email blast was sent to football families regarding Boosters Club Meeting
- Janna and Ronda not yet able to meet to zero balance all senior accounts and move \$ to general account.
- Janna met with Coach Pees to review and update Website

COACHES REPORT / Matt Pees

- Freshmen signing day – make a big deal of this event for the incoming Freshmen. Have the players sign a “letter of intent.” JV and Varsity players should attend this event to show solidarity and encourage new players; add excitement to the program. Dylan to speak. Need to obtain roster for new Freshmen from Van Davis. Send an email and get RSVP info.
- 4Q to start – Mon, Wed, Fri at 6am. Incentives have been set for days attended. Funds needed to fulfill these incentives will be about \$3000.

FUNDRAISING REPORT / Rachael Alford

- It was decided that the Mulch Program would not be utilized this year. Participation was not overwhelming last year and the funds should be made up with other programs easily.
- Two Chipotle Night fundraisers will be planned. These can raise upwards of \$3000.
- Rent-A-Ram to use “When I Work App” – cost for this setup - \$300. Each player should raise \$100 for work performed between May and August. Once a player has earned \$100 for the team account, they can bank additional money in their individual account. Incentives for number of hours worked were discussed and need to be finalized. Ideas included gift cards for Top 5 sellers and one random drawing.
- Further discussion of Freshman Signing night included providing and paying for food for the event. It was decided we would have the event catered by Olive Garden for about \$700 – this would include the incoming Freshmen players and their parents. Kim Schulz offered to sponsor pizza for the JV and Varsity players in attendance – about 40 people. Event details – Wednesday, May 3; 430pm setup; 515pm JV and Varsity Players arrive; 6pm incoming Freshmen arrive.
- Other fundraising business discussed – Tumbler program scheduled for after break, Pees to hold meeting with players to discuss expectations, players take orders and \$ for Tumblers, orders are placed and then Tumblers will be delivered.

FUNDRAISING CON'T:

- May try for (3) Chipotle Nights – Sept, Nov and maybe Dec.
- Rachael offered to organize a Poker Night and Silent Auction through her business. Discussion was started as to types of donations to seek and a date in November was suggested.
- It was discussed that the 4 big fundraisers should be able to generate roughly \$52,000 for our program and that our program needs should run around \$50-60,000.
