Rochester Youth Hockey has the belief and philosophy that the overall hockey experience shall be a fun and enjoyable one. It is therefore necessary that players, parents and staff members conduct themselves in a responsible manner from the moment they enter an ice arena until the time they leave. It is up to all of us to set a proper example for everyone around us. The actions of each and every one of us reflect upon all of us and upon the entire organization. Our organization is beginning its 31st year and is highly respected in the community. It must be understood by all players that running around, horseplay, fighting, abusive language and other **UNACCEPTABLE BEHAVIOR ... WILL NOT BE TOLERATED!**

Should anyone from the staff of Rochester Youth Hockey feel that conduct was not appropriate, the league will discuss the matter with the player and their parent. Should a situation continue and a resolve to that issue come to a stall, the player may be asked to leave the organization.

The behavior issue applies equally to parents. Abusive language, foul behavior, taunting of other players, fans or referees **WILL NOT BE TOLERATED!** Equally, disruptive behavior from a parent disgruntled over an issue with his or her own child, will not be acceptable. If there is a problem with any member of Rochester Youth Hockey's coaching staff or an issue over the development of your child, it must be brought to the attention of the Board of Directors. We will be happy to discuss the issue with your child and you in private at any time. Conversations should be conducted in a mature and constructive manner. Conversations in public **WILL NOT BE ACCEPTED!** Once we have reached a decision over an issue, we would ask for your support and to move forward.

Any issues of safety and security must also be brought to the Board of Directors attention. Any issues involving threats will be taken seriously. Any offense, which may be illegal by local laws, will be dealt with as such and the local authorities may be brought in.
