#### Secretary:

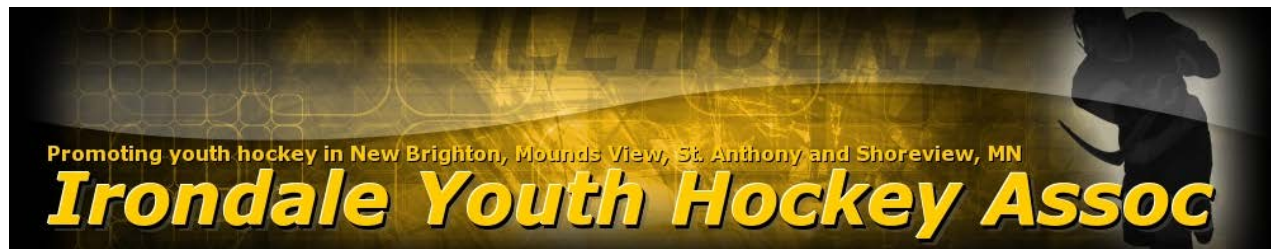
- Please let me know if you want additional communications from me to the IYHA parents in addition to what comes from MVI.
