Treasurer: Not present, no report.

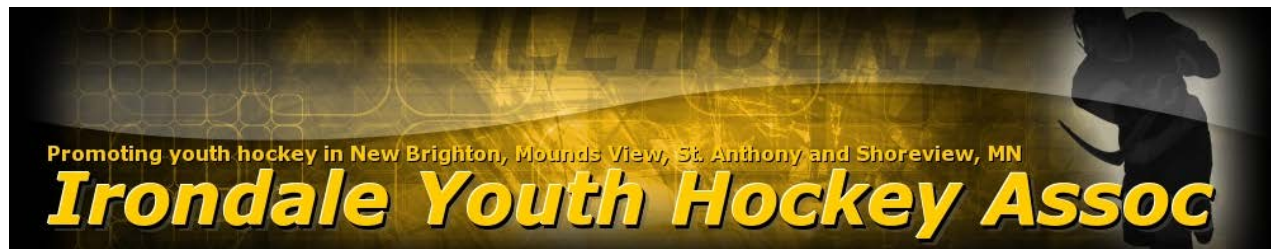
Boys Program Coordinator:
