4. Old Business
  - NC Coach and Parent issue-Rob Jones NC 4<sup>th</sup> grade Coach- NC board last month voted and proposed to the FCFL that both Rob Jones and the parent involved being suspended for the first game of the 2009. They will not be allowed to attend the game or be in the stadium/area around stadium. They will be closely monitored in the future and NC board has committed to a zero tolerance policy on future violations. Darien, Westport, Wilton voted in favor of NC recommendation. Fairfield voted for termination of the Coach.

Policy committee will review an exception policy to allow (or disallow) the kids to remain in NC program and also review a possible exception policy that will apply to all future conflicts.
