Equipment: Steve has a rough draft of an equipment check out form. Tiffany suggested changes with the form and will be in contact with Steve.

Schedules: There will be more discussion on this after evaluation day and final sign ups. As of now there are 214 kids signed up total. There would be 4 teams for 4/5/6, 5 teams for 7/8, 7 teams for Minor, and 5 teams for Major. Lindsay motioned to amend game times to 6:00 p.m. instead of 5:30 p.m. 2<sup>nd</sup> to motion was Brian.

Evaluation Day: Everyone needs to attend evaluations if at possible. Be at AMS at noon and will leave at 4:30. There will be 3 stations; front door and both gyms.

Drafts: All drafts are at Emma B with the celebration of teams to follow each night. Drafts start at 6:00 p.m. Coaches need to be there by 5:45 p.m. Monday 3/16 is Majors, Tuesday 3/17 is Minors, Wednesday 3/18 is coach pitch 7/8 and Friday 3/20 is coach pitch 4/5/6.

Coaches: Open discussion on one coach versus two coaches.
