PROGRAM PURPOSE

Vernon Soccer Club (VSC) strives to provide an affordable sports experience for all participants. VSC aims to offer some financial aid to players who demonstrate need. There is a finite amount of aid available each season, based on VSC's annual budget. This policy includes information on how the program works as well as what financial aid covers. FINANCIAL AID DEADLINES

Families requesting financial aid must complete the VSC Financial Aid Form either through the online option available on the VSC website (<http://assn.la/Reg/?r=1:199475>), or by submitting a hard copy form. Families are required to complete one form for each player for whom they are requesting aid. Financial Aid Form due dates are listed below:

- **Spring soccer- Feb 15th / Fall Soccer –August 15th**

FINANCIAL AID AWARD LEVELS

Award levels vary according to need and are granted in increments of 25%, 50%, 75% & 100% financial aid. In the case of similar need, applications will be processed according to the date they were received.

Families will be notified of their acceptance or denial of financial aid by mail or email. A signed contract including payment will be due;

- **Spring Soccer- March 15th / Fall Soccer –August 31st**

PROOF OF NEED

VSC will use qualification for free or reduced school lunch as the primary determining factor in granting financial aid. For those who qualify for either of these programs, proof of eligibility is required. If a family does not qualify for either of these programs, there is an area on the application form to explain extenuating circumstances for requesting aid.

CONFIDENTIALITY

All financial aid applications completed online are done so on a secured web server and hard copy forms submitted will only be reviewed by the VSC President, Registrar & Treasurer.

Financial aid is not paid directly to any applicant but will be used to reduce registration fee.

FINANCIAL AID FREQUENTLY ASKED QUESTIONS

Q: How Do I Apply For Financial Aid?

A: The preferred method is the online application available at: <http://assn.la/Reg/?r=1:199475>.

Q: How Much Aid Is Available, Am I Guaranteed Aid?

A: VSC budgets a set amount of financial aid each year, so not everyone applying will automatically receive it.

Q: What Does Financial Aid Cover?

A: Financial aid covers a portion of a player's registration fee. Financial Aid does not cover required shin guards or socks for soccer season or any required uniforms for travel.

Q: What Factors Go Into Awarding Financial Aid?

A: The VSC Financial Aid Program largely depends on a family's qualification for free or reduced lunch and requires proof of eligibility for either of these programs. For those requesting aid but do not qualify for free or reduced lunch, the Financial Aid Application includes a section to explain extenuating circumstances for aid requests.

Q: When Will I Know If I Qualify For Aid And Amount Of Award?

A: Families will be notified by mail or email of program acceptance or denial and the amount of award based before the beginning of each season. If awarded aid, the letter will include an agreement outlining the commitment required to receive aid and the amount granted. Those being offered financial aid will have one week to return a signed copy of the agreement.

Q: If I Have More Than One Player In My Family, Do I Need To Complete A Financial Aid Application For Each One?

A: Yes, VSC requires a separate form for each member of the family.

Q: Do I Need To Complete A Financial Aid Form Each Year I Need Aid?

A: Yes, VSC requires each family to complete a new application each season.
