

**Riverside High School Athletic Booster Club**

- I. **Welcome/Call to order:** Richard Burton called to order the May 11, 2015 RHS Booster club general meeting in the Media center at Riverside High School at 6:29pm. Present were board members, booster club members and athletic coaches.
- II. **Team roll call:** Team roll call done by Karen Van Horn for 9 teams represented by coaches or parent representatives designated by coaches.

  - C. Concessions (spirit wear) – sold at games and open houses.

- VI. **Athletic Department Review:** Spring season is wrapped up. Lacrosse, baseball and women’s soccer will go to next level playoffs. New softball coach introduced.
- VII. **Coach’s recognition and comments:** 2014-2015 Coach of the Year voting by the coaches was for Coach Jones. Women’s Lacrosse doesn’t have a feeder school so Coach Campbell has to teach the girls as they enter. Coach Howell graduated over the weekend from UNC.
