DAN WARBURTON

Dan Warburton has been the varsity girl's lacrosse coach at Cheshire High School for the past 16 years. During his tenure, the Rams have a record of 231-87-3. In the Southern Connecticut Conference, Warburton's Rams have won six SCC

Tournament Championships, and won or shared nine SCC Regular Season Championships. Warburton's Lady Rams played in the 2012 Class L State Championship Game and have also made three state semi-final and seven state quarterfinal appearances. Warburton was named the 2017 Southern Connecticut Conference D1 Coach of the Year. In 2011, Warburton was named Connecticut Class L Coach of the Year. Warburton was also the 2004 and 2012 New Haven Register Coach of the Year.
