### **Code of Conduct and Attendance Policy**

In an effort to improve the quality of play, technical ability, and team chemistry, the Northeast United Premier Soccer Club, (hereinafter "Club"), requires each player, through his parent, to agree to abide with the Code of Conduct and Attendance policy (hereinafter "Policy") detailed below, by signing this Agreement. While exceptions to the Policy can be made, for valid reasons, said exceptions are only at the discretion of the coach, or Northeast United.

1. Attend, be prepared and arrive on time for all practices, games and team functions; unless prior arrangement is made with the coach of the team in accordance with this policy.
2. **No player shall play a local club game prior to the premier game play in the same day. No player is allowed to play for an opposing club team against their NEU team during the any season.**
3. Each player is expected to be at the field, no later than 45 minutes prior to the scheduled kickoff.
4. Each player must attend all tournaments, both home and away; unless prior arrangement is made with the coach of the team in accordance with this policy.
5. **Each Player will not engage in any destructive, immoral, or disruptive behavior to include the use of foul language either verbal, written or by other electronic means.**
6. **Each Player WILL act in a responsible manner that reflects as a positive endorsement for the Club at home or away games and tournaments.**
7. Each player will not use or have in their possession, any alcoholic beverages, illegal drug substances, or tobacco products
8. Players must notify the coach and manager within 3 days of receipt of the game schedule, if there is a scheduling conflict (vacation, family, academic, etc.) with any game that appears on the schedule.
9. Coach/manager should be informed of emergencies such as a family crisis or illness as soon as possible, prior to game time.
10. If a player violates the Policy and is suspended, or has his playing time reduced, that player must still attend the game(s) and participate in the practice(s) during the suspension period.

**Players failing to follow the club's Code of Conduct will be sanctioned accordingly by the Head Coach, DOC(s) and/or the President of the Club.**

**Consequences for Violation of the Policy set forth in this document include but are not limited to:**

1. Verbal warning from Head Coach
2. Reduced playing time at the next game or series of games. Removal from tournament roster for a determined period of time
3. **Suspension of playing privileges for a determined amount of time**
4. Dismissal from the Club.

Additionally:

Red Cards will be reviewed by the DOCs and/or the President. All suspensions served are the responsibility of the player. Continued Red Card offenses will be considered a serious violation of this Club Handbook and the Player Agreement and its guidelines and as such will be subject to review by the President and DOCs to determine disciplinary action.

By signing below, we, both the Player and Parent, agree to abide by the Attendance Policy detailed above. We further understand that any tuition we have paid will be non-refundable, regardless of the sanctions that may be imposed for the violation of this policy.
