### Minutes

1. Roll Call Greg Ritter
  
2. Modified Checking for JV
  - A. Greg Ritter confirmed that Bollinger will protect middle school players, even with full checking.
  - B. Brief discussion
    - i. Modified checking is recommended by US Lacrosse.
    - ii. Tyna Murphy indicated the intent is to teach kids how to play.
  - C. Several people expressed concern with middle school girls playing varsity. This is an acknowledged inconsistency in our league. A couple schools have middle school girls playing varsity. Without the middle school girls, these clubs would not have enough players to field.
  - D. Vote (includes proxy votes)
    - i. Yes – implement modified checking 16
    - ii. No – allow full checking 6
  - E. SouthWest Roundup – JV games will use modified checking. No out of state teams are JV level.
  
3. Other
  - A. Corona petition for player to play out of their area.
    - i. History – Corona petitioned for 2 girls from Queen Creek to play with Corona. One is the coach's daughter; the other is a friend. The EC approved the coach's daughter to play with Corona, but denied the second girl. Corona requested the situation to be reconsidered, because of the close relationship with the girl and the coach's daughter and the car pooling arrangement with the coach.
    - ii. Discussion.
      - a. If the girl does not play for Corona, she will not have the ability to play due to lack of transportation.
      - b. Gilbert would be the closest cub. Gilbert does not oppose this request.
    - iii. Decision – the majority of those present approved to allow the girl (Coach's daughter's friend) to play with Corona for the 2011 season.
