The subject Bylaws shall be amended to read as follows:

In ARTICLE II insert the following:

G. Travel Team Coaches

Selection of all Travel Team Coaches shall be by majority vote at a Board of Directors meeting to be held annually in April. Coaching candidates who wish to be considered shall submit an application for coaching for review by the Board of Directors. Said application shall be submitted prior to a Board of Directors Meeting to be held annually in March.

The subject Bylaws shall be amended to read as follows:

In ARTICLE II insert the following:

H. Age Classification

Registration of all players will be limited, by division, to the Age Classification as published by USA Hockey. No player will be allowed to move up to a division higher than the published USA Hockey "Age Category", "Age Division" classifications.

The subject Bylaws shall be amended to read as follows:

Article II

Section A. Annual Meeting

The Annual Meeting of the Corporation shall be held before the 15<sup>th</sup> of April, and is open to all active and honorary members of the Corporation. At this meeting, an estimated year-end financial report shall be presented by the Treasurer. The Corporation fiscal year will begin June 1<sup>st</sup>.

Article II

Section G. Travel Team Coaches

Selection of all Travel Team Coaches shall be by majority vote at a Board of Directors meeting to be held annually in March. Coaching candidates who wish to be considered shall submit an application for coaching for review by the Board of Directors. Said application shall be submitted prior to a Board of Directors meeting to be held annually in February.

The subject Bylaws:

Article II

D. Board of Directors

The Board of Directors shall supervise the operation of the League and any Corporation Facility. A Board member shall resign from the Board by written notification, which shall be effective upon receipt thereof at the next regular Board meeting. The President may with approval of the Board request resignation of any Board member by majority vote of the said Board of Directors. Upon such request, said Board membership is immediately vacated.

Shall be amended to read as follows:

Article II

D. Board of Directors

The Board of Directors shall supervise the operation of the League and any Corporation Facility. A Board member shall resign from the Board by written notification, which shall be effective upon receipt thereof at the next regular Board meeting. The President may with approval of the Board request resignation of any Board member by majority vote of the said Board of Directors. Upon such request, said Board membership is immediately vacated.

Any Board member absenting themselves from three (3) meetings, per term, without cause shall have their office declared vacant at the discretion of the Board of Directors.
