### **CALL TO ORDER**

#### ROLL CALL

ACCEPT THE MINUTES A MOTION (second) to accept the August minutes passed unanimously.

#### **NEW BUSINESS –**

2013-14 Mites. While the mandate is that all U8 plays less than full ice, there is a process where exceptions may be granted. These exceptions are made in very limited circumstances and are only issued if authorized by the USA-H Player Development Committee.

A MOTION (second) was made to authorize Tom Regan to petition USA-H for an exception whereby CHC would be permitted to allow full ice competition with these limitations: that games are played after January; that only players age 8 may participate in full ice competition; and that no more than 15 such games can be played during the remainder of the season. DISCUSSION was made with inquiry made whether squads would be created for programs that do not have enough 8yo players; there will be accommodations made for interested 8yo to participate in this type of competition. Other inquiry was whether this exemption is a permanent exemption, and the sense is that exemptions would need to filed each year. It was also clarified that NY is not looking for an exemption. Further discussion supported the position that this proposal advances the ADM model: it provides a window to allow players to transition to full ice play that they will experience at SQ level; further, the timing is such that late in their season these players should experience full ice as they advance through ADM.

The Motion PASSED unanimously. Tom will prepare and submit the petition to USA-H.

## **REPORTS**

**Treasurer.** Mike Federico reported that the Fiancée Committee (Mssrs. Regan, Federico, Lanza, Blakeslee and Meakem) met to conduct its annual review of the CHC books, and the review found no issues. Mr. Meakem provided an overview of the process that the Finance Committee undertakes.

Mike also reported that CHC recorded a small loss for the prior year.

**Coaching Education Program. Amy Landino** reported that spots are open for certain coaching clinics. Please use the website for time/availability. She also reminded us that Coaches need to be screened in accordance with the established practice. **Tournament Committee.** Art Blakeslee presented the tournament schedule. Solicitations for hosting a tournament will begin next month. All proposals are due in November.

Re-declaration is available for programs. The re-declaration must be made by an OFFICER (President or other Board of Director) of the Member Program. DO NOT REDECLARE USING THE DECLARATION FORM.

**Eligibility (Kathy Ludwig)** Screening for new coaches is mandatory. Thereafter, screenings are made every other year. This year 1700 coaches were screened. Board members are also subject to screening.

**District Commissioners:** The Midgets are causing problems in each District. FIGHTING is an automatic 2-game suspension. These are games that were already in existence and were posted through League Athletics – no "insert games" satisfy the game suspension.

**Registrar.** (Sue McCullough) Sue again reminded everyone that unrostered players or worse, non-registered teams are a very serious issue. If an unrostered player is discovered, then the coach is also subject to a one-year suspension.
