## **Code of Conduct**

- Each Player or Cheerleader shall address Coaches and Officials with the utmost respect. Examples: Yes Sir, No Sir, Yes Ma'am, and No Ma'am.
- If any Member of South Orlando Braves is ejected from a game/event, that member will not participate in the remainder of that game/event. The SOYFA Board will review the incident to determine if further discipline is necessary.
- No Player or Cheerleader shall criticize other players or teammates.
- Each Player or Cheerleader that misses greater than 50% of the practices the week of a game will be not allowed to participate that weekend. **NO EXCEPTIONS!!**
- There shall be no profanity, obscene gestures, verbal threats, and physically threatening action on or off the field.
- At any game, practice, event, or competition, any adult who: 1) verbally abuses; 2) attempts to intimidate; 3) is flagrantly rude or 4) cannot control their language or actions with an official, coach or SOYFA volunteer will be asked to leave the event. He or she will receive a written warning regarding the behavior after the event. His or her child (ren) will be immediately removed from the event. The warning will be given in writing prior to the next event (i.e.- game, practice, event, or competition)
- Any adult that commits a second similar offense will be banned from SOYFA/Pop Warner events for the remainder of that season and their child (ren) removed from SOYFA/Pop Warner for the remainder of that season.
- Any adult who physically assaults an official, coach or volunteer will be banned from SOYFA/Pop Warner and their child removed from the SOYFA/Pop Warner program for one year from the date of the offense. After one year, the parent may apply for re-instatement of his or her child. If the adult commits a second offense, he or she will be permanently removed from SOYFA/Pop Warner. (The term physical assault includes, but is not limited to: hitting, slapping, pushing, spitting, kicking, or striking in any way with any part of the body or any physical implement.)
- Parents will be responsible for ensuring your child (ren) is at practice on time and picked up on time.
- There shall be no use of tobacco on or off the field.
- There shall be no use of alcoholic beverages or illegal substances on or off the field.
- No Parent/Coach/Participant Dispute will be discussed during the games or practices. Contact the coach by phone after the event allowing all parties a "Cooling Off" period. Never discuss the dispute in front of the players/cheerleaders. **(ZERO TOLERANCE)!** If the conflict can't be resolved then both parties can utilize the forum established by the SOYFA Executive Board. This forum will allow all disputes to be heard with a ruling made by the Board of Directors as to any disciplinary action.
- During All Games & Practices: Adults and children not directly involved as either a certified coach or requested volunteer (Chain gang, Mandatory Play Rule Keeper, Game Medic, etc) will not be permitted on the field, on the bench area with the team or on the track. You must remain on the other side of the fence preferably in the stands.

Any violations of the above mentioned rules will result in a suspension and/or discipline as determined by SOYFA Board of Directors. Each member, as a representative of SOYFA is expected to uphold the Code of Conduct and shall obey the rules and regulations of SOYFA. Everyone's behavior is a reflection of our league.

## Policy #03 Refunds

- 1) The beginning of the first practice (for reasons other than those listed below) - **FULL REFUND LESS \$100 NON-REFUNDABLE DEPOSIT**
- 2) Player is over/under the weight limit and cannot move up or down to the next level (prior to the beginning of the first practice) **FULL REFUND**
- 3) Family moves out of the area( prior to the beginning of the first practice)- **FULL REFUND**
- 4) Medical reason accompanied by official documentation from a physician(prior to the beginning of the first practice)- **FULL REFUND**
- 5) **Once a player has practiced with a team- NO REFUNDS WILL BE ISSUED**
- 6) **Cheerleading- NO REFUNDS will be issued once the cheer uniforms order has been placed**

**The \$100.00 deposit is non-refundable and non-transferable. The deposit has held a roster spot for your child and is therefore non-refundable and non-transferable**

All requests for refunds **MUST** be in writing and submitted to either the Football or Cheer Commissioner and approved by the SOYFA Board of Directors. All refund requests are reviewed on an individual, case by case basis.

## Policy #09

### Volunteer Time Requirements

SOYFA depends 100% on volunteers to function. We have many needs throughout the season. To help us meet those needs each SOYFA family is required to volunteer **4 HOURS** each season. Failure to meet this requirement will render participants ineligible for early registration for the following season. This requirement applies to the families of tackle football and cheer participants. The time required is per family **NOT** per participant.
