- f. Pre load names of wrestlers into software
- g. Post results by club needs to be printed
- h. Seeding would be optional and based on additional evaluations
- i. Pair wrestlers manually as needed or based on previous scores/records
- j. Bout sheets vs video projection
- k. Hot spots for internet access
- I. ID numbers and scheduling or assignments to mats
- m. Target three matches or more
- n. Print results for each wrestler by club for easy distro of ribbons
- o. Paper bout sheets
- p. Electronic scoring is a nice to have
- q. Ability to allow wrestlers to bump down/ up if heavy/light for age
- r. Ability to wrestle up in next age group
- 10. Bill Marck made arrangements for NVWF team to work with Bill Swink, VAWA Director, to learn about Track Wrestling features since Mr. Swink has experience in this. He is also a member of the Stafford Highlanders per discussions from Troy. Mike Gingras and others stated that directions are posted on the NVWF website describing how to operate the current NVWF tournament software. Mr. Gingras said that the software is not very forgiving whereby the entire operation could fail if an operator proceeds with steps in the wrong sequence. Only a few persons in the NVWF have actual hands-on extensive experience operating the software to include Christina Bennett and Shannon Matheny; two other "meet" managers were trained last year to include Corrin and Hannah.
