Release & Consent

In consideration of being allowed to participate in any way in Winter Garden Ice Arena Programs, Private Ice Rental, and related events and activities, including all aspects of travel, the undersigned member and/or parent/guardian for minor age members:

1. Acknowledge and fully understand that each participant and/or observer will be engaging in activities that involve risk of serious injury, including permanent disability and death which might result not only from their own actions, inactions or negligence, but the actions, inactions or negligence of others, the rules of play or the conditions of the premises, or of any equipment used. Further, that there may be other risks not known to us or reasonably foreseen at this time.
2. Furthermore, the novel coronavirus, COVID-19, has been declared a worldwide pandemic by the World Health Organization. COVID-19 is extremely contagious and spreads from person-to-person contact. Danbury Arena has put in place preventative measures to reduce the spread of communicable diseases; however, we cannot guarantee that you or your child(ren) will not become infected while attending our facilities. While we've implemented reasonable preventive measures, we depend on each and every visitor and their families to follow the guidelines from the Center of Disease Control, and all applicable federal, state, and local health department guidelines, rules, laws, and regulations before and while visiting our premises. We are all in this together and rely on each other to adhere to the above-mentioned guidance and legal restrictions. The undersigned fully understands and acknowledges both the known and potential dangers of utilizing our facilities, services, and programs and acknowledge that use thereof by the undersigned and/or such participating children may, despite our reasonable best efforts to mitigate such dangers, result in exposure to communicable diseases, which could result in quarantine requirements, serious illness, disability, and/or death.
3. Acknowledge all the foregoing risk and accept personal responsibility for the damages following such injury.
4. Release, waive, discharge, and covenant not to sue Winter Garden Ice Arena, their administrators, directors, agents, business affiliates, other employees of the organization, and other members, from all liabilities to each of the undersigned, his or her heirs and next of kin for any and all claims, demands, losses or damages on account of injury, including death or damage to property whether incurred on the ice or otherwise in or about the building or grounds, or traveling related to Winter Garden programs, caused or alleged to be caused in whole or in part as the result of participation in or observation of skating, hockey, or other activities.
5. Grant permission, if I/we the undersigned parent(s) or guardian(s) cannot be reached for any said person to obtain medical care and treatment from any physician, nurse, ambulance attendant, hospital or medical clinic, should the undersigned become ill or injured during skating, or related activities.
