It is that time again – annual renewals of membership. I have spoken with some of you so you have an update. As you know, the renewal checks need to be at USFSA by July 1, or the judges will not be allowed to judge and the skaters will not be allowed to compete, so, hopefully you will write your check, and send back to me upon receipt of this letter (or e-mail if I have an e-mail address for you). As best as I can tell, most of our members have had a fairly good year. Our competitors continue to compete, however, the deLaski's in Florida have taken up a little hockey. Daniel Raad again went to Nationals in Sr. Men and Jr. Pairs and did very well. Our judges had interesting assignments with the new judging system and in particular I had a wonderful Olympic experience judging the men's event – see picture enclosed. Sadly, we have a change in officers since my stepfather - David Gerli – passed away reluctantly at 98 in November. We have replaced him with Ed Cossitt since he is in NYC and I need the president nearby to sign the NPF tax documents for us.

As reported last year, the Blacks moved to Greensboro, NC and are looking forward to seeing us at Nationals that will be held there in 2011. As usual, we could use new members, so if anyone would like to propose a new member, please submit the name with all the usual supporting letters of recommendation so that the admissions committee can review.
