**What will be provided for you:** 1 table with tablecloth, 2 chairs, ice and dump buckets, and "runners"

*You will be able to sell products to go at the event for customers to pick up on their way out.*

**Electric** is available at no cost, however, all needs must be requested in advance. Electrical needs communicated during the event cannot be met. Acceptable items plugged in include cash register and lights. Anything that heats or cools needs prior approval.

**Power/Utilities:** Electrical services are at a premium and all needs must be communicated well in advance of your arrival via an order form. Vendors are expected to bring any power strips needed to accommodate their order,

**Security:** Security and law enforcement officers to be on patrol during event. However, this in no way implies responsibility on the part of the Greater Canandaigua Civic Center for lost/stolen items.

**Worker Entry:** Each vendor will receive two vendor credential badges per booth set up. These badges are for working staff only. Each vendor will receive one parking pass for a supply/delivery vehicle. All other worker vehicles may park in the general parking lot.

**Licenses/Permits:** We will be operating under a temporary beer, wine and cider permit. Each vendor will need to provide us with a copy of your **New York State Liquor Authority Marketing Permit** and each vendor is required by law to have a valid **New York State Certificate of Authority to Collect Sales and Use Tax** prominently displayed at your booth and on file with the Greater Canandaigua Civic Center by **March 17, 2019**.

**Insurance:** The VENDOR, its affiliated companies and subsidiaries shall secure and maintain during the period of this Agreement Comprehensive General Liability Insurance including liquor liability, which shall be written on an "occurrence" basis, with a standard broad form endorsement and/or excess umbrella liability with combined single limit of not less than One Million Dollars (\$1,000,000) for each occurrence and Two Million Dollars (\$2,000,000) general aggregate.

On such policy, the VENDOR agrees to name as additional insured's Greater Canandaigua Civic Center, Inc., its parent, subsidiaries, limited liability and affiliated companies and their respective shareholders, officers, directors, employees, members agents and assigns ant to provide a certificate of such coverage no later than March 17, 2019 and the certificate must specifically state that it is "primary and non-contributory over any other insurance that may be available to an indemnified Party and contains a waiver of subrogation in favor of certificate holder."

VENDOR hereby releases and forever discharges the Greater Canandaigua Civic Center and all sponsoring organizations and their respective directors, officers, employees, agents and volunteers from any responsibility, personal liability, claims, loss or (including reasonable attorney's fees) arising out of or in conjunction with VENDOR'S application to or participation in or involvement with the Growlers, Grapes, and Grains event.

VENDOR agrees that VENDOR shall assume full responsibility for injury to person or property of others, including employees, agents, patrons or other person, which shall occur by reason of VENDOR'S involvement or participation in the Growlers, Grapes, and Grains event.

VENDOR acknowledges and agrees that it is their understanding and agreement that the Growlers, Grapes, and Grains event and all sponsoring organizations and their respective directors, officer, employees, agents and volunteers shall incur no liability whatsoever to, or on account of VENDOR, or VENDOR'S employees or agents, arising out of VENDOR'S participation in or association with the Growlers, Grapes, and Grains event. The Growlers, Grapes, and Grains event and all sponsoring organizations and their respective directors, officers, employees, agents and volunteers will not be responsible for any injury sustained any vendors, workers or guests while within the exhibit space.

The VENDOR shall indemnify and hold harmless those listed above from and against any and all claims, liabilities or damages of whatever nature, including but not limited to, claims of bodily injury, death, personal injury, property damage, by whoever made, as well as the cost of litigation and attorneys' fees arising from, based on or in any manner related to vendor's activities in connection with its involvement in or participation with the Growlers, Grapes, and Grains event.
