Call to Order

South Central District Vice President Joseph Conte called the meeting to order at 7:06 pm.

Secretary's Report

Michael Galbicsek, Jr. distributed the minutes from the July South Central District meeting. The minutes were also emailed to the clubs/SCD Board. After a brief discussion regarding the minutes

Treasurer's Report

Michael Hanlon-SCD Treasurer reported that the district has a strong cash position however he stressed all clubs to submit a transmittal form upon completion of each season. Hanlon asked that, moving forward, this be completed by December 1 and July 1 respectively. This method will allow Hanlon to balance the SCD monies properly.

There was a discussion whether or not to fine clubs who fail to comply; this was tabled until the September South Central District meeting. There were no questions for Treasurer Hanlon.

Registrar's Report

Patrick Duffy-SCD Registrar informed all in attendance that he is beginning to upload and approve rosters for the Fall 2012 season. He asked that all clubs be sure to get their birth certificates and proper information together or the rosters will not be approved. There were no further questions for Duffy.

District Referee Administrator's Report

There was no referee report since Raul Marques-SCD DRA was absent.

Girl's Commissioner's Report

Scott Bradley-SCD Girls Commissioner informed the group that he is currently revising the divisions due to several last minute changes/requests from clubs. Bradley stated he will entertain specific requests from Club Representatives after the meeting.

There was a discussion with regards to implementing a U-11 Travel Rec division however the majority of the members present disapproved of making a change this late in the process.

Boy's Commissioner's Report

Bill Cadwell-SCD Boys Commissioner reminded all in attendance that the fall 2012 scheduling session will be held on August 26, 2012 from 12:00-5:00 at the Cheshire Youth Recreation Center. Cadwell also stated he is in the process of revising the divisions due to several late entries and requests. That stated, the schedules will be posted on the SCD website by August 25, 2012.

Finally, Cadwell reminded all clubs that the team coach and manager must sign up to the SCD website in order to receive their pin number. If this does not occur there will be no way to submit scores/schedules. Club Presidents will be noted as the interim contacts for teams that do not follow through online.

U-10 Commissioner's Report

Brian Grindrod-SCD U10 Commissioner and Recreation Director reminded all clubs that the U10 brackets will be posted online late Saturday night. All clubs were reminded that the U10 division does not have tryouts and there must be at least 50% U9 and 50% U10 players on the teams (essentially there cannot be a team comprised of only U9 players, however there can be teams with only U10 players). After a brief discussion involving clarification on the U10 rosters there was no further questions for Grindrod.

State/CJSA Report

Brian Grindrod-CJSA Representative reminded all Presidents and Representatives that CJSA will be holding their annual President's and Registrar's meeting on August 26, 2012 at the Farmington Marriott.

Vice President's Report

Joseph Conte-SCD Vice President reminded all clubs that their affiliation forms are past due and any changes (due to recent elections) must be submitted to the CJSA office. Additionally, all clubs were reminded that teams will have to submit scores by the Monday (11:59pm), following their game. The home team is responsible for submitting scores. Fines can be imposed if the scores are not submitted by the deadline.
