Call to Order

South Central District Registrar Patrick Duffy called the meeting to order at 7:10 pm.

Secretary's Report

Treasurer's Report

Michael Hanlon-SCD Treasurer was absent from the meeting however all clubs were reminded to verify/submit their transmittal forms via the SCD website no later than October 15, 2012.

The June 2012 SCD Treasurer's report was tabled until the October South Central District Meeting.

Registrar's Report

Patrick Duffy-SCD Registrar informed all in attendance he has approved all properly submitted rosters that were sent to him. A request was made to have clubs submit any birth certificates to him for verification (all ages) as soon as they receive them. Duffy also reminded all clubs to upload not only their travel rosters but their in-house rosters as well. There were no further questions for Duffy.

District Referee Administrator's Report

There was no referee report since Raul Marques-SCD DRA was absent.

Girl's Commissioner's Report

Scott Bradley-SCD Girls Commissioner stated scheduling went well and that there were limited to no issues with the girls divisions at this point.

Boy's Commissioner's Report

Bill Cadwell-SCD Boys Commissioner agreed with Bradley-indicating scheduling had limited issues. There was a discussion with regards to the size of the divisions however and the group agreed that this was ultimately up to the commissioners who oversee the divisions.

Finally, Cadwell reminded all clubs that the team coach and manager must sign up to the SCD website in order to receive their pin number. If this does not occur there will be no way to submit scores/schedules. Club Presidents will be noted as the interim contacts for teams that do not follow through online.

U-10 Commissioner's Report

Brian Grindrod-SCD U10 Commissioner and Recreation Director reminded all clubs that U10 teams require certified rosters and all U10 coaches must have passes in order to be on the sidelines. There were no further questions for Grindrod.

State/CJSA Report

Michael Galbicsek-SCD Secretary reported on behalf of Brian Grindrod, as Grindrod was absent from the September CJSA meeting. Galbicsek reminded clubs:

-Club Reaffiliation forms are past due-you must resubmit the forms every time you have elections, change personnel or, at minimum, once a year for the CJSA to have current contacts.

-Be sure to spell the child's full name when registering him/her. This is important and will avoid a delay in registering the players with the state system. Do not forget to use the state id numbers.

-Connecticut Cup is currently underway. The District Commissioners are not the Cup Commissioners. That said please remind your coaches to submit the scores to the Cup Commissioners the same day as the cup event. You also need to connect with Raul Marques, SCD Referee Administrator in order to obtain referees.

Vice President's Report

Joseph Conte-SCD Vice President was absent from the meeting therefore no formal report was made.

Old Business

New Business

SCD Registrar Patrick Duffy reminded all clubs to complete the club transmittal form (located on the left hand side of the website) before October 15, 2012.
