

Minutes of the Regular Meeting

Baldwinsville Boys Lacrosse Booster Club
June 12, 2013

Shelly nominated Michael Candee for Treasurer, Ken seconded the nomination and all in attendance were in favor.

Scholarship winners were announced. Parker Ferrigan, Matt Paddock, Matt Zandry and Ronnie May were awarded scholarships.

TREASURER'S REPORT: Mike reported there is still \$1,200.00 still outstanding in advertising fees for the program.

About \$2,000 will be billed to Pete after his registration fees come in for tournament reimbursement.

The club is in good financial shape.

TOURNAMENT REPORT: Ken reported that Coach decided to hold his summer camp at Jones Rd. The camp will not be run through the booster club this year.

However, the club will post the flyer on the website as a courtesy to Coach. Pete will reimburse the club for two tournaments that were paid with booster club funds.

Ken will send the We Got to Believe Tournament waiver tonight. Payment will be collected at the field because of short notice.

Discussion was held about Syracuse Shootout on July 7th. Ken will investigate if there is an opening and if we can field a team and obtain a coach.

FUNDRAISING: All boys except one boy raised funds. Hugh followed up with the family. They turned in \$50.00 to team rep. A total of \$9,697.95 was raised.

The raffle drawing was held at meeting. Winners were as follows: Paul Norton, Pat Towne, Chris Tierney, Karina Watkins, Dickman Family, Duffy Family, Georgina Stanton, Hall Family and Lisa Morrow. A ticket was also drawn that read "Donate."

CONCESSIONS: We need someone to take over Concessions. Adrienne Rutkowski resigned as her son graduated.

This season the concession stand opened just prior to end of J.V. game. This worked out well and should be continued next season.

Meeting adjourned at 7:25 pm.

NEW BUSINESS: Booster meetings will not be held in July and August.
