## THE 2018 OVE SUMMER LEAGUE

### TIMES:

Games will be played at 5:30PM, 6:30PM, 7:30 and 8:30PM on Tuesday and Thursday nights, starting Tuesday, May 31st and running through Thursday, June 28th.

### TOURNEY INFO:

There will be no tournament play. Each team will play 11 games. Please let us know with any special requests and we will do our best to accommodate schedules. We will do our best to have all of each team's games for the week on the same night, especially teams that will be traveling from further away. We will be mindful of scheduling around team camps and tournaments that some of us participate in during June (Metro State, DU, Gold Crown, C3 Challenge, etc.). **Cost is \$450 per team.** Checks can be made out to Danny Fisher and money is due by your 1st game or before so that we can get our officials paid. We will have varsity level officials for each game. **OUR MAIN FOCUS IS QUALITY COMPETITION AND QUALITY OFFICIATING.** Please have each player complete a liability waiver before competing, which is attached with this info sheet.

### RULES:

- Two, 20 minute halves with a running clock. Clock will not run during timeouts.
- Clock stops with 2 minutes left in the second half, unless a team is up by 12 or more points.
- Each player gets 5 fouls.
- Each team will have 3 timeouts for the entire game.
- Bonus – 7 team fouls; Double Bonus – 10 team fouls.
- Free-throws will be awarded and count as they do in a regular high school game (2 or 3 FT's on shooting foul, 2 FT's in double bonus, etc.)
- 2 FT's and possession will be awarded on technical fouls
- **Overtime:** 2 minutes, each team receives 1 timeout (none carry over from regulation). Jump ball to start.
- **Double Overtime:** Sudden Death, No timeouts. Jump ball to start.
