Rules and Regulations:

Licensee agrees to abide by the terms and conditions of this Permit Contract, Chapters 20 and 21 of the Scottsdale Revised Code, and specific facility rules, regulations and policies, as applicable. Licensee agrees to comply with all federal, state, county and local laws, ordinances, rules, regulations, and policies pertaining to Licensee's use and the Resource.

Indemnification:

Licensee agrees to the fullest extent permitted by law, to defend, indemnify and hold harmless the City of Scottsdale, its agents, representatives, officers, officials, and employees from and against all allegations, demands, proceedings, suits, actions, claims, damages, losses, injuries, illnesses, accidents, and expenses, including but not limited to attorney fees, court costs, and the cost of appellate proceedings relating to, arising from or out of, or resulting from use of the Resource by the Licensee, its employees, agents, guests, vendors, contractors, subcontractors and the above-listed group. The above defense, indemnity, and hold harmless obligations do not apply to claims resulting from the sole negligence of the City of Scottsdale.

General Provisions:

Licensee understands that this Permit Contract is revocable at any time by the City of Scottsdale Community Services Director or authorized representatives.

If payments are not received by the due dates set forth in the Payment Schedule, this Permit Contract will automatically terminate. Cancellation or changes must be made 30 days in advance of initial permit use date or all fees will be forfeited. The processing fee will be charged on permit cancellations and refunds. Additional charges will be imposed if areas are not left clean.

If signing on behalf of a company/organization, I warrant and represent that I am properly authorized and empowered to enter into this Permit Contract on behalf of the above-named company/organization.
