

Agreement for use of McLean County PONY Baseball Complex and Facilities

1. The applicant, their organization and members are bound by this agreement, its terms and conditions, and regulations and ordinances pertaining to the use of the McLean County PONY Baseball Complex.
2. McLean County PONY Baseball, Inc. does not assume any liability for property lost or stolen on the premises, or for personal injuries sustained on the premises during facility use, and the user organization agrees to hold McLean County PONY Baseball, Inc. harmless for all claims, suits, judgments or damages arising out of such property loss or personal injury.
3. PONY does not provide insurance coverage to applicant or its participants, including but not limited to medical insurance. Applicant's participants represent and agree they have their own medical insurance and further agree that participants assume the risk of participation in athletic events.
4. No gambling, lotteries or raffles shall be performed. No alcohol or controlled substances may be brought or consumed upon the premises. It is agreed that violation of this provision shall result in automatic revocation of all rights hereunder and the forfeiture of all fees.
5. No food or beverages are to be brought inside the Complex. Players are allowed to bring in a personal water bottle – no glass containers. Pets are not allowed inside the Complex.
6. The user organization will be responsible for and will pay any damage to McLean County PONY Baseball Inc. arising out of the use of the Complex pursuant to this agreement.
7. McLean County PONY Baseball reserves the right to have a representative present for the purpose of supervision.
8. All groups using the facilities will be responsible for any set up that they may require and be held responsible for the clean up of the facility after their scheduled use.
9. All groups must park in designated lots only. Vehicles may not be driven onto playing fields. Permission may be granted to allow a vehicle to transport materials and equipment too heavy to carry by hand. No vehicles shall be driven on the turf within 72 hours of substantial rainfall, or if ground is determined to be too soft to allow vehicular travel without undue damage. Any such damage will be charged to the user.
10. The decision to cancel an event due to weather or field conditions will be at the discretion of the user organization. However, an event may also be cancelled if an official of McLean County PONY Baseball, Inc. determines the fields to be at risk of damage.
11. If lightning occurs before or during an event, the user organization agrees to obey the lightning policy of McLean County PONY Baseball Inc.
12. Equipment owned by the user organization must be removed from the facility within ten days of program completion. Equipment left behind will be disposed of at the cost to the organization.
13. The user organization agrees to pay McLean County PONY Baseball, Inc. a fee of \$25 per event held at the Complex plus the actual cost of any products or materials used, such as chalk, Turface, etc. payable at end of season.
