

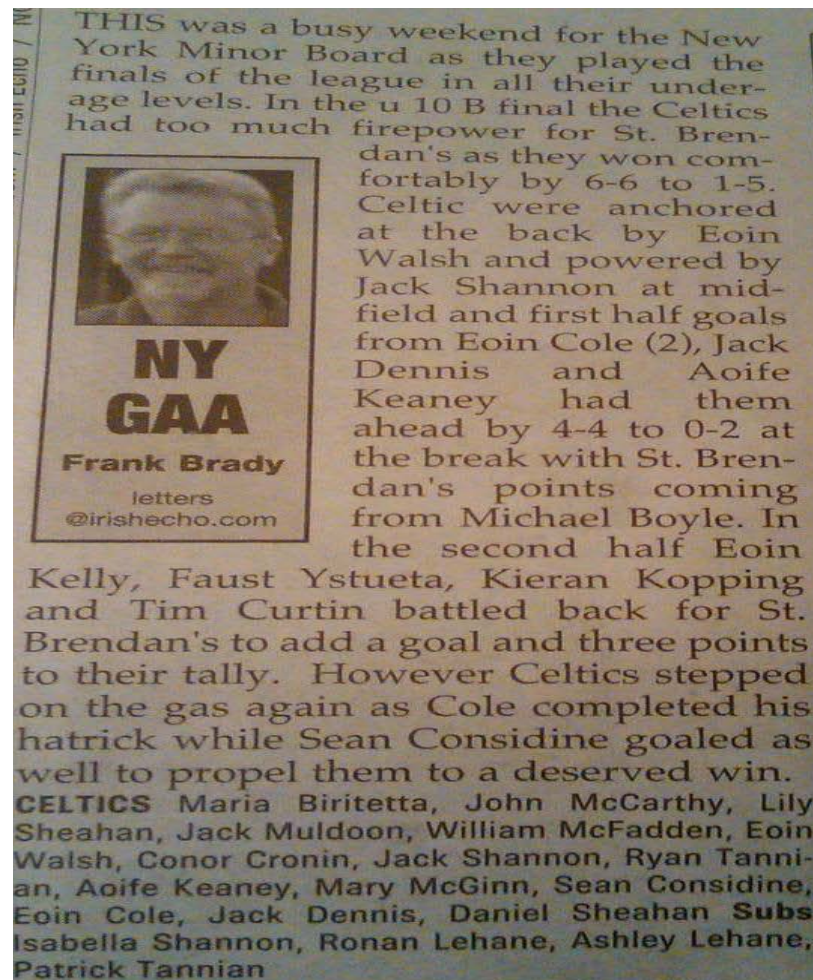

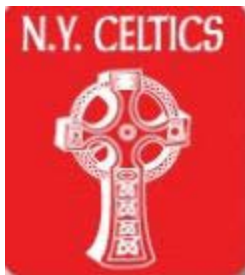
The NY CELTIC Club

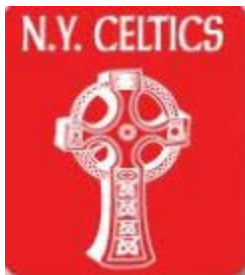
The Club Executive Committee is the controlling Body of the Club, managing the business and affairs of the Club. It is essential that the Executive Committee is active and well managed. The Executive Committee shall be comprised of the Chairperson, Vice Chairperson, Treasurer, Recording Secretary, Correspondent Secretary, Registrar, Public Relations Officer, Sgt at Arms & Managers



The Executive Committee and Sub-Committees

The NY Celtics need to have a committee structure in place facilitate the organization and the management of Club activities. Every Club is required by rule to have a Club Executive Committee. The Club also has a number of sub-committees in place to help with certain aspects of administration and activity. The Club Executive Committee and the use of sub-committees in the Club will be discussed in further detail.

It is recommended that a sub-committee should consist of no more than five members and should report to each Executive Committee Meeting. Sub-Committees are generally quite small but can be given powers of co-optation of people outside of the Executive Committee who are considered to have particular expertise in a certain area

of a Club elects the Executive Committee to administer and manage the business and affairs of the Club.

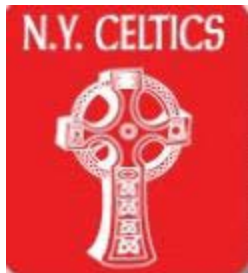
Only Full Members, whose membership fees are paid up to date in accordance of the Club constitution, and who are not suspended or disqualified are eligible to vote at the AGM.

One of the most effective methods of sharing and delegating work in the Club is through the appointment of Sub -Committees.

The appointment of Sub-Committees is a valuable way of involving and interesting a large number of Club members in management and policy making by giving them a definite part to play in the life of the Club.

There are advantages for the Club in the appointment of sub-committees in that they allow decision making by a smaller group while allowing members with specific expertise to concentrate on their particular area of interest

Coaching and Games Development Sub Committee

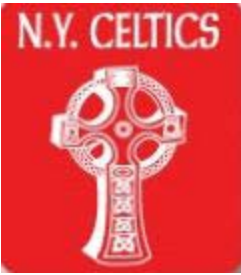
This sub-committee should be responsible for ensuring that a sufficient Games program exists in the Club and that various GAA Games Development initiatives are being used to maximum potential. It should also ensure that there is a Club/school link in operation in the Club. The Club Coaching and Games Officer should be chairperson of this committee.



Social and Cultural Sub Committee

This sub-committee should plan a program of social and cultural activity involving as many people as possible. It should include in its program, a plan for active cooperation in the promotion of the Development of the GAA games. The Club PRO should be Chairman of this committee.

“Membership and Registration”

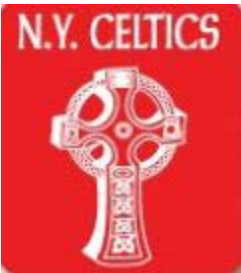
Membership and Registration Sub Committee for CYC

The responsibility of this sub-committee is to ensure that all Club members, players and officials are registered in accordance with rule. The sub-committee should also ensure that team list and age regulations are complied with. The Club Registrar should be chairperson of this committee

The Membership Year

The Club membership year runs from AGM to the following GM. Persons must have their Club fees paid on a date prior to March 31st as laid down by the Club, and be registered in order to have a vote at any Club meeting in the upcoming membership year. Therefore, if the Club has a special general meeting in June, it is those who paid their fees prior to the previous deadline and have been registered that are entitled to vote. If a person pays their Club fees prior to any meeting for the first time of will be eligible to vote.
