Football: Discussed low registration for JV- Ben said he would contact eligible players since there is no head coach at this time.

Cheer is based on age only not grade therefore moving up only permitted with consent of coach and coordinator and cheerleaders who move up cannot fly. Price locked in at \$147 for 2 years (normal price is \$197 per uniform). Bows are being upgraded to competition grade bow at practice bow price from a local lady.
