- within the IIHF in which case I undertake to submit any such dispute to the jurisdiction of the Court of Arbitration for Sport (CAS) in Lausanne, Switzerland for definitive and final resolution.
3. I am aware that transferring to another country may affect my eligibility to play for the national team of my choice if applicable.
 4. I understand that once this application has been completed and signed by the parties specified and then by the IIHF, the procedure will be complete and the transfer legal and binding.

The above IIHF Transfer Card (ITC) is to be used for non-US Citizens (excluding Canadians) to transfer to a USA Hockey member junior program (regardless of age). Male 18 year old players transferring to a USA Hockey member youth/midget program (residency documents required). Women's players 18 years, or older (residency documents required). It is recommended that player is in the USA prior to processing the ITC in order to obtain signatures and process within timeline. The fees are as follows:

- Junior players \$1500 USD
- Male players 18 years old transferring to a youth/midget program \$500 USD.
- Female players 18 years, or older \$500 USD (excluding adult women's recreational leagues for ages 30 & over, 40 & over, 50 & over).

DIRECTIONS: When completing the form, print clearly and do not abbreviate club name.

1. Complete the following blanks on the above ITC form; Name, Player's Signature, Place of Birth, DOB, Citizenship, Last Club, New Club, *Duration of transfer. The lines for old national association and new national association must be left blank.
2. The team should complete the bottom part of this form; **include complete address & credit card information.**
3. Submit the form via fax or email to USAH for processing – 719.538.1160 or transfers@usahockey.org.
4. After form is submitted, USAH will process the ITC with the outgoing federation & credit card payment.
5. Once the approved ITC is received at USAH from the outgoing federation and the IIHF & the credit card is approved, USAH will then approve in the USAH Registry or the USAH Junior Registry.
6. The original ITC will be sent overnight to incoming team to process the original ITC in the same manner. USAH will enclose a return envelope and ITC should be returned within 7 days of receipt. After original ITC is returned to USAH, your team has completed the ITC process.

* Please note: If applying for duration of unlimited for transfer, a UTCR form must be submitted with transfer form, also be prepared to submit player contract to USA Hockey as the outgoing federation will likely request a copy.

TIMELINE: An international player will not be added to a protected list until the approval from outgoing federation and IIHF is received. This process takes a **minimum of 3 days** (not to exceed 7 days from when ITC is sent to outgoing federation).
