Little League rules will apply, with sponsored umpires from each League.

A minimum of 9 players per team (no maximum). 10 can play the field with a continuous lineup.

Each player must sign the "Release From Liability" form included below.

Home team determined by coin flip. Games played for six innings (or 1.5 hours).

Trophy awarded at the end of the championship game. The winning League holds their trophy for one year.
