QUALIFYING GAMES:

ROUND 1 - HIGHER SEED HOSTS GAME

UMPIRES DETERMINED BY SITE

JV/VAR ROUND 2 AND JV ROUND 3 - HIGHER SEED HOSTS GAME

UMPIRES DETERMINED BY SITE

VARSITY ROUND 3 - HIGHER SEED HOSTS GAMES 1-3. LOWER SEED HOSTS GAME 2. CHAIRMAN MAY SWITCH SITES FOR GAMES 1-2

UMPIRES DETERMINED BY SITE

SEEDING TOURNAMENT: (INCLUDING CHAMP QUALIFYING GAMES)

HIGHER SEED HOSTS ALL SEEDING TOURNAMENT GAMES.

UMPIRES DETERMINED BY SITE

NOTE: ALL QUALIFYING GAMES (INCLUDING J.V.) HAVE PRIORITY OVER SEEDING TOURNAMENT GAMES. IN CASE OF FIELD CONFLICTS, THE SEEDING GAME WILL BE MOVED TO ANOTHER DATE. VARSITY PLAYOFF GAMES HAVE PRIORITY OVER J.V. PLAYOFF GAMES. IF TIME PERMITS, THE GAME WILL BE PLAYED ON ANOTHER DATE. IF NOT, THE GAME WILL BE MOVED TO ANOTHER SITE. IF THE SEEDING TOURNAMENT IS NOT COMPLETED BY THE DAY PRIOR TO THE START OF THE CHAMPIONSHIP TOURNAMENT, THE SEEDING TOURNAMENT WILL BE CANCELED AND TEAMS SEED ACCORDINGLY FIRST ROUND GAMES (IF PLAYED) IN THE SEEDING TOURNAMENT WILL BE CONSIDERED

VARSAITY CHAMPIONSHIP TOURNAMENTS:

UNLESS SPECIFIED, LEAGUE DESIGNATED SITES WILL BE USED. HIGHER SEED BATS LAST
EXCEPTIONS: VARSITY ONLY

FIRST GAME OF CHAMPIONSHIP TOURNEY FINALS - UNDEFEATED TEAM BATS LAST
SECOND GAME OF CHAMPIONSHIP TOURNEY FINALS - HIGHER SEED BATS LAST
IN AA DIVISION, LOSER GAME I, BATS LAST IN GAME M
IN A DIVISION, LOSER GAME G, BATS LAST IN GAME I

JUNIOR VARSITY TEAMS MAY HOST GAMES EXCEPT FINALS
WHICH WILL BE PLAYED AT A LEAGUE DESIGNATED SITE.

TEAM HOSTING GAMES MUST GUARANTEE CURFEW WILL NOT SUSPEND GAME

**TEAMS SPLIT UMPIRE FEES (\$120.00) FOR ALL PLAYOFF GAMES. THIS INCLUDES CHAMPIONSHIP GAMES
ASSIGNOR FOR ALL GAMES DETERMINED BY CHAIRMAN
TWO UMPIRES ASSIGNED TO ALL SEEDING AND PLAYOFF GAMES / FOUR UMPIRES ON CHAMPIONSHIP GAMES**

NO BATTING PRACTICE OF ANY TYPE MAY BE TAKEN PRIOR TO THE GAME

BOTH TEAMS SUPPLY BASEBALLS FOR ALL PLAYOFF GAMES

ALL PLAYOFF GAMES MUST BE PLAYED TO COMPLETION. ALL MERCY AND PITCH COUNT RULES EFFECT

PROTESTS -

When a game is protested, the umpires shall contact the chairman (or his designated representative) immediately. A ruling will be issued before the game will continue. Teams may protest this ruling. Protests involving two teams from the same diocese will be handled as described in the by-laws. Protests involving two teams from different diocese will be resolved in the following way:

The chairman will appoint a committee of three coaches no longer involved in this division's playoffs. The committee will also consist of one executive board member from each diocese.
