Where: Stiks Academy 965 Cannon Gate Road, Oconomowoc, WI 53066

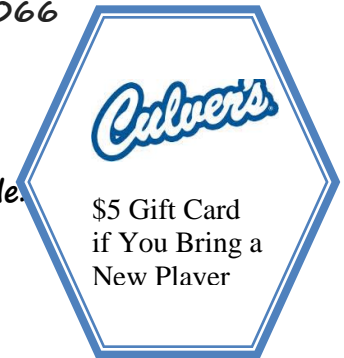
Why: To learn to play lacrosse and have fun!!
