FUNDRAISING POLICY:

How our Program works:

- Cheerleading families must earn 10 points for the season for CHYC. Each point is worth \$10.00 and the total required to raise is \$100.00
- Cheerleading families select which fundraisers they would like to participate in and earn points based on successful completion of the fundraiser.
- Parents who do not wish to participate in fundraising may opt for a tax deductible fundraising buyout of \$100.00.
- If parents fail to raise \$100.00 they will be billed the difference.

UNIFORMS:

Recreation uniforms are loaned to cheerleaders during football season and should be returned in the same condition as it was delivered to the cheerleader.

For Recreation Season:

- Each participant will receive a CHYC Cheer Shell and matching Skirt.
- **A \$75.00 check deposit is required when the uniform is loaned to the participant. The \$75.00 deposit will not be cashed and will be returned to the participant once the uniform is returned. If the uniform is not returned, the 75.00 will be cashed by CHYC.**
- Upon return, the uniform will be inspected by CHYC and any damage (tears, rips, pulls, stains) other than normal usage will be the parent responsibility to correct.
- To help care for the uniforms, CHYC requests that:
 1. The Uniform NOT GO in the Dryer and is hung flat to dry.
 2. The uniform not be altered in any way.
 3. The participant must refrain from eating items that will stain the uniform unless a protective garment is worn over the uniform.
 4. The uniform must not to be worn at any other time except during a football game competition or event.
 5. The uniform must not be loaned to anyone other than the participant.
- Parents will be responsible for providing white sneakers, bloomers and crop top/turtlenecks. Sneakers can be purchased from Payless Shoes and bloomers and crops from My Dance Bag, Cherry Hill.

Uniform Deposit:

I understand that I will be required to leave a \$75.00 check or credit card number as deposit for release of the CHYC Recreation uniform. I understand the check or credit card will not be cashed unless I fail to return the uniform or the uniform is damaged.
