

**AGREEMENT AND RELEASE OF LIABILITY  
(Lincoln-Way Xplosion Basketball Club Tryout)**

I (“Releaser”) acknowledge that I, and my participating children identified below (“Participating Children”) have voluntarily agreed to participate in the activities during the Lincoln-Way Xplosion Basketball Club Tryout (“Tryout”).

I am aware that the activities at the Tryout involve risk of bodily injury, permanent disability, death, economic loss or property damage to me and/or my Participating Children. I, and my Participating Children, are voluntarily participating in these activities with knowledge of the danger involved and assume any and all risks of injury, death, or property damage.

In consideration of being permitted by the Lincoln-Way Xplosion Basketball Club to participate in these activities, I, personally and as parent and legal guardian of my Participating Children, agree that I and my spouse, children, heirs, distributes, guardians, legal representatives, and assigns waive and relinquish any and all claims against the Lincoln-Way Xplosion Basketball Club, its present and former officers, directors, members, agents, servants, and employees, and their administrators, executors, successors and assigns, for any injury, death, or property damage occurring to me or my Participating Children as a result of my or their participation in the Tryout activities, whether caused by the negligence of the Lincoln-Way Xplosion Basketball Club, its present and former officers, directors, members, agents, servants, and employees, or otherwise.

In addition, I, personally and as parent and legal guardian of my Participating Children, release and discharge the Lincoln-Way Xplosion Basketball Club, its present and former officers, directors, members, agents, servants, and employees, and their administrators, executors, successors and assigns, from all actions, claims, or demands that I and my spouse, children, heirs, distributees, guardians, legal representatives, or assigns now or in the future may have for any injury, death, or property damage resulting from participation in the Tryout conducted by the Lincoln-Way Xplosion Basketball Club.

I agree for myself and my spouse, children, heirs, distributes, guardians, legal representatives, and assigns that in the event that any claim for personal injury, death, or property damage will be prosecuted against the Lincoln-Way Xplosion Basketball Club, its present and former officers, directors, members, agents, servants, and employees, including but not limited to any claims by my children, I will indemnify and save harmless the Lincoln-Way Xplosion Basketball Club, its present and former officers, directors, members, agents, servants, and employees from any and all such claims or causes of action by whomever made and wherever presented.

I have carefully read this release and fully understand its contents. I am aware that this is a release of liability and a contract between myself, personally and as parent and legal guardian of my children, and the Lincoln-Way Xplosion Basketball Club, its present and former officers, directors, members, agents, servants, and employees and sign it of my own free will.
