

**BURNSVILLE BOYS TRAVELING BASKETBALL ASSOCIATION
SUMMER OPEN GYM WAIVER/RELEASE FORM**

IN CONSIDERATION OF _____, (Name of Minor Child/Ward) my child/ward, being allowed to participate in any way in the **Burnsville Boys Traveling Basketball Association (“BTBB”)** related events and activities, the undersigned acknowledges, appreciates, and agrees that: The risk of injury to my child from the activities involved in these programs is significant, including the potential for permanent disability and death, and while particular rules, equipment, and personal discipline may reduce this risk, the risk of serious injury does exist; and,

- 1) FOR MYSELF, SPOUSE, AND CHILD, I KNOWINGLY AND FREELY ASSUME ALL SUCH RISKS, both known and unknown, EVEN IF ARISING FROM THE NEGLIGENCE OF THE PARTICIPANTS, spectators or, administrators, others, and assume full responsibility for my child’s participation; and
- 2) I willingly agree to comply with the program’s stated and customary terms and conditions for participation. If I observe any unusual significant concern in my child’s readiness for participation and/or in the program itself, I will remove my child from the participation and bring such attention of the nearest official immediately; and,
- 3) I myself, my spouse, my child, and on behalf of my/our heirs, assigns, personal representatives and next of kin, HEREBY INDEMNIFY, RELEASE AND HOLD HARMLESS **BTBB**; its directors, officers, officials, agents, employees, volunteers, other participants, sponsoring agencies, sponsors, advertisers, and if applicable, owners and lessors of premises used to conduct the event, WITH RESPECT TO ANY AND ALL LIABILITIES INCIDENTS, INJURY, DISABILITY, DEATH, or loss or damage to person or property incident to my, or my child’s/ward’s involvement or participation in these programs, WHETHER ARISING FROM THE NEGLIGENCE OF THE RELEASEES OR OTHERWISE, to the fullest extent permitted by law.
- 4) Athlete/Participant – By signing this document, I agree to abide by all rules and obligations & behavior expectations set forth in the **BTBB** player policy. I know and understand this opportunity is a privilege and will treat all court supervisors with respect and courtesy and will abide by their decisions respectfully. I also agree to represent myself and BTBB with the utmost respect on and off the court while participating in this opportunity inside/outside Burnsville High School. I understand if my behavior/attitude is not conducive to the program I am participating in, I will be asked to leave open gym and the incident documented. If a second incident is documented, I will be suspended for one session. Upon receipt of a 3rd documented incident, I will not be allowed to return to the Summer Open Gym Program and may forfeit my opportunity to participate in the 2018-19 BTBB basketball season, as determined by the **BTBB** Board. This opportunity is intended to be competitive, but fun. Behave respectfully or be gone. No exceptions.

I UNDERSTAND THERE IS NO MEDICAL TRAINER NOR MEDICAL SUPPLIES AVAILBLE ONSITE (including, but not limited to, ice etc). I HAVE READ THIS RELEASE OF LIABILITY AND ASSUMPTION OF RISK AGREEMENT, FULLY UNDERSTAND ITS TERMS, UNDERSTAND THAT I HAVE GIVEN UP SUBSTANTIAL RIGHTS BY SIGNING IT, AND SIGN IT FREELY AND VOLUNTARILY WITHOUT ANY INDUCEMENT.
