

Memo from Missoula Lacrosse Clubs:

Below are the general rules for playing at Missoula Parks. Lacrosse clubs in Missoula are fortunate to have a great relationship with the parks department. We will strictly enforce these rules.

The general membership of Missoula Lacrosse Club, Hellgate Lacrosse, Big Sky Lacrosse, Sentinel lacrosse will have appointed Field Marshals at every event. These Field Marshals will enforce the rules- any team choosing to ignore the rules and ignore the Field Marshall will be asked to leave.

Organizations breaking the park rules will receive a written warning, and are subject to fines by the Missoula lacrosse Clubs; this may also include your club being eliminated from playing at the City of Missoula Parks. The violation will be assessed to the entire offending club.

Signing the attached Rules of Missoula Parks and Rec will be required before teams are booked to play. Teams will be responsible to send out these rules to their team membership in advance of team play.

Not Allowed In Parks

The following are not allowed in parks:

Attachment D – Bella Vista Synthetic Turf Field

Permit holders who are intending to use the Bella Vista synthetic turf field (BVF), with or without lights, must ensure their user group adheres to the following guidelines:

- Initial** My organization agrees to abide by all Missoula Parks and Recreation park policies while using the facilities
- Initial** Permit Holder agrees to follow and abide by the posted rules sign at the BVF entrance. We understand that failure to adhere to these rules will result in loss of our Good Standing Status (attachment) which is required to secure future park reservations.
- Initial** Permit Holder agrees to police participants to properly dispose of all garbage in appropriate containers and check the field for trash debris prior to the end of rental period each day.
- Initial** All pets are strictly prohibited within the fenced area. Failure to adhere to this rule will result in the loss of Good Standing Status (attachment).
- Initial** Glass containers, seeds with shells (ie. sunflowers, peanuts etc.), confetti, paint or adhesives, tobacco products, wood chips, heat-producing devices and weapons are strictly prohibited in the field area.
- Initial** The consumption of alcohol is only permitted in specified containers to those teams who hold a valid alcohol permit with Missoula Parks and Recreation in specified areas.
- Initial** Stakes are prohibited and can damage the field's irrigation system and soil sensors. Items needing to be secured (ie. Tents, canopies, etc.) must use weights, water buckets or sand bags in good repair.
- Initial** All advertisement and/or sponsorship banners on the fence must be secured using only carabiners not stakes or zip ties. Banners must be set-up and taken-down within the rental period.
- Initial** There shall be no attempt at field preparation by outside organizations. Trained Missoula Parks & Recreation Staff shall be the only ones to prepare fields for play.
- Initial** Permit Holder agrees to immediately report any observed problems with the fields, lights, restrooms, etc. to the Missoula Parks and Recreation Superintendent 552-6273.

I have read and understand all of the restrictions listed on this form. As a representative of my organization I agree to the above restrictions and will ensure users follow all the park rules and BVF restrictions. I understand that should damage to the park result from misuse or violation of these restrictions part or all of the deposit may become forfeit.
