BY ITS NATURE PARTICIPATION IN ATHLETICS INCLUDES A RISK OF INJURY WHICH MAY RANGE IN SEVERITY FROM MINOR, TO LONG-TERM CATASTROPHIC, TO EVEN DEATH. Although serious injuries are not common in supervised athletic programs, it is impossible to eliminate this risk. Participants can, and have the responsibility to, help reduce the chance of injury. **PLAYERS MUST OBEY ALL SAFETY RULES, REPORT ALL PHYSICAL PROBLEMS TO THEIR COACHES, PROPERLY MAINTAIN THEIR EQUIPMENT, INSPECT THEIR EQUIPMENT DAILY, AND IMMEDIATELY REPORT ANY PROBLEMS WITH THEIR EQUIPMENT TO THE COACHES.**

MAMFA DOES NOT SCREEN APPLICANTS FOR ILLNESS, INJURY, ALLERGIES OR OTHER MEDICAL CONDITION which could prevent or limit the participation by the applicant in athletics or outdoor programs. It is the responsibility of the parents and guardians of each Player to determine the Player's fitness to participate in the athletics or outdoor program.

By signing this release I acknowledge that I have read and understand the above warnings. I do not know of any medical condition which would prevent or limit the participation of the Player in athletics or outdoor programs, including MAMFA activities. I certify that I am the parent or legal guardian of the Player. I give my permission for the Player to participate in MAMFA activities.

On behalf of myself and the Player named above (the "Player") me I expressly **ASSUME ALL RISK** of injury, death and damage to the Player and the Player's property arising from the Player's participation in MAMFA activities and travel to and from MAMFA activities.

On behalf of myself and the Player, I hereby **DISCHARGE AND RELEASE** MAMFA, and each and every of their respective officers, directors, representatives, coaches, agents, and volunteers ("the Released Persons") from any and all liabilities, claims, demands, and causes of action which may arise, in any way, from the Player's participation in MAMFA activities, or the Player's travel to or from MAMFA activities, whether caused in whole or in part by the **NEGLIGENCE** of any of the Released Persons or otherwise.

On behalf of myself and the Player, I further agree to **INDEMNIFY AND HOLD HARMLESS** the Released Persons any and all liability, loss or damage of any kind from claims, demands, costs, judgments, or other expenses of any kind (including attorney's fees) in any way arising from or in connection with any personal injury or death or property damage in connection with the Player's participation in MAMFA activities, or the Player's travel to or from MAMFA activities, whether caused in whole or in part by the **NEGLIGENCE** of any of the Released Persons or otherwise.

Any controversy or claim arising out of or related to this Release shall be settled by arbitration in accordance with the applicable Arbitration Rules of the American Arbitration Association, and judgment upon the award rendered by the arbitrator (s) may be entered in any court having jurisdiction thereof.

I certify that I have carefully and fully read this Release. I fully understand the terms, conditions and consequences of this Release. I have signed this Release voluntarily and willingly. This Release shall be binding upon me, the Player, my spouse, heirs, personal representative, successors and assigns.
