Athletes Warehouse LLC. Health Liability Waiver

I am aware that in addition to the usual dangers and risks inherent in the strength and conditioning of youth and adult training as well as other Athletes Warehouse LLC. activities, certain additional dangers and risks are present when using Athletes Warehouse LLC. Facilities, strength and conditioning equipment, including, but not limited to, the danger and risk of falling, jumping, landing, lifting, running, height and motion. By signing this waiver, I freely accept and fully assume responsibility for all such dangers and risks and the possibility of personal injury, death, property damage or loss resulting therefrom.

In consideration of utilizing the Athletes Warehouse LLC. Facilities equipment and for other good and valuable consideration, I hereby agree as follows:

1. **TO WAIVE ANY AND ALL CLAIMS for personal injury including death, illness, and/or property damage that I or my child may have against Athletes Warehouse LLC., their principals, directors, sponsors, interns, DBA (doing business as), independent contractors, affiliates, spectators, employees, representatives and any volunteers, and or any individual present in Athletes Warehouse LLC. and or any contracted space, in any way associated with Athletes Warehouse LLC., all of whom are hereinafter collectively referred to as “the Releasees”.**
2. **TO RELEASE THE RELEASEES FROM ANY AND ALL LIABILITY for any loss, damage, injury, death, medical or other expense that I or my child may suffer or that any other party may suffer as a result of my use of Athletes Warehouse LLC. Facilities Equipment and or I or my child’s participation in any training related or other activities that may be held at or sanctioned by Athletes Warehouse LLC.**
3. **TO HOLD HARMLESS AND INDEMNIFY THE RELEASEES from any and all liability for any property damage or personal injury to any third party, resulting from my use of Athletes Warehouse LLC. Equipment or by my child’s participation in training related activities or other Athlete Warehouse LLC. activities. THIS RELEASE OF LIABILITY SHALL BE EFFECTIVE AND BINDING upon my heirs, next of kin, executors, administrators, successors, and assigns in the event of mine or my child’s personal injury including death, illness, and/or property damage.**
4. **I ADDITIONALLY AGREE that my child and I shall follow correct safety procedures when using Athletes Warehouse LLC. Facilities Equipment. I also expressly grant to Athletes Warehouse LLC. and any third party authorized by them, the right to film, videotape, photograph, collect data that is used for research, publishing and or educational purposes, record my child’s voice and make any reproductions of my child’s physical likeness and voice, and the irrevocable right in perpetuity to use, display, and digitally enhance such likeness in any media now known or hereafter devised, including, but not limited to, the exhibition and/or online use, broadcast, theatrically or on television, cable, or radio, any motion picture, video tape, DVD, CD or any Internet Service or program in which such likeness may be used or otherwise, or any published articles and research journals, catalogs, or websites in which such likeness may be printed, used or incorporated, and in the advertising, exploiting, and publicizing of the Facility, Facility products, licensed products, and all affiliated relationships. It is understood, that Releasees shall have the right to use any material (i.e. footage or photographs) shot in connection with the Athletes Warehouse LLC. programs for any reason whatsoever.**
5. **I ADDITIONALLY AGREE that if my child and/or I are to enroll in any membership agreement, classes, private training, strength training or any other service potentially provided at or by Athletes Warehouse LLC. and or the Releasees. My child and/or I are knowingly accepting all responsibilities, with regard to our knowledge, understanding, and adherence to correctly**

performing any exercises, workouts, or any movement in or outside the Athletes Warehouse LLC. With this understanding I agree that it is completely my child's or my decision to follow any statement, suggestion, or guidance provided by the Releasees. Additionally, I am therefore, accepting any and all responsibility for any injuries, damages, or claims suffered in or outside of Athletes Warehouse LLC. due to adhering to any suggestions, statements or guidance (including but not limited to any program in the print or digital format) provide by the Releasees.

I ADDITIONALLY AGREE that if I am renting any portion of Athletes Warehouse LLC. and or any additional space they have contracted, I am knowingly accepting all responsibility for any injuries, damages, and claims, that may result during my rentable time in Athletes Warehouse LLC. and or any additional contracted space. I ADDITIONALLY AGREE that by signing this document I understand that by releasing the company Athletes Warehouse LLC., I am also releasing any and all employees, management, owners, and subsidiaries, companies and or individuals that Athletes Warehouse LLC., may own, rent from or be partnered with.

I HEREBY CERTIFY THAT my child and or I is covered by his/her own Medical Insurance, and that I have read and understand this Release of Liability prior to signing it, and I am aware that by signing this Release of Liability I am waiving certain legal rights which I, my child, or our heirs, next of kin, executors, administrators, successors, and assigns may have against the Releasees.

Athletes Warehouse LLC. shall have the right to impose any additional conditions which, in the opinion of the Releasees, will further the intent and legal rights and waivers provided herein.

This Liability Waiver was made and executed in the New York and shall be governed by, enforced in and construed in accordance with the laws of the State of New York.

I am acting on behalf of the attendees other parent in signing this contract and I have authority to bind such other parent to the terms and conditions of this contract on his or her behalf.
