<p>Rule 35 Penalties</p> <p>No current Rule Would become 35.4 Leading With the Head</p>	<p>Any player during the course of making contact with another player who is observed by any official to be leading with their head will be flagged and removed from the game for three (3) plays. No other penalty will be enforced for the first offense and the result of the play will stand.</p> <p>Any player who is flagged a second time for leading with their head will result in an unsportsmanlike penalty for that player and removed from the game for the remainder of the half.</p> <p>Any player receiving a third penalty for leading with their head during a game will receive a second unsportsmanlike penalty and be ejected for the remainder of the game.</p>

The intent here is to make this offense a teachable moment for the player as well as emphasize safety. This rule does not supersede the NHSF "Targeting" rule but enhances Rule 9-4.3 Illegal Helmet Contact.

This rule applies to the 2015 season going forward. All players on JMFA rosters in 2014 will be grandfathered for 2015.</p>
