Jefferson County Midget Football Association Release of Liability for Minor Participants:

JEFFERSON COUNTY MIDGET FOOTBALL ASSOCIATION RELEASE OF LIABILITY FOR MINOR PARTICIPANTS READ BEFORE SIGNING IN CONSIDERATION OF my minor child (my child), being allowed to participate in any way in the Jefferson County Midget Football Program, including related events and activities, the undersigned acknowledges, appreciates and agrees that:

1. The risk of injury to my child from the activities involved in this Program is significant, including the potential for permanent disability and death, and while particular rules, equipment and personal discipline may reduce this risk, the risk of serious injury or death does exist.
2. I declare that to the best of my knowledge and belief, my child is in good health and physical condition to engage in youth football activities.
3. FOR MYSELF, SPOUSE, AND CHILD, I KNOWINGLY AND FREELY ASSUME ALL RISKS, both known and unknown, EVEN IF ARISING FROM THE NEGLIGENCE OF THE ORGANIZERS, SPONSORS or others, and assume full responsibility for my child's participation.
4. I, for myself, my spouse, my child, and on behalf of my/our heirs, assigns, personal representatives and next of kin, HEREBY RELEASE the other participants, leagues, member associations, sponsoring agencies, sponsors, advertisers, and if applicable, owners and lessors of premises used to conduct the event (Releases), WITH RESPECT TO ANY AND ALL INJURY, DISABILITY, DEATH, or loss or damage to person or property incident to my child's involvement with or participation in these programs, WHETHER ARISING FROM THE NEGLIGENCE OF THE RELEASEES OR OTHERWISE, to the fullest extent permitted by law.
5. I, for myself, my spouse, my child, and on behalf of my/our heirs, assigns, personal representatives and next of kin, HEREBY INDEMNIFY AND HOLD HARMLESS the Denver Broncos Football Club and Stadium Management Company and the Jefferson County Midget Football Association and all of its Member Associations; Arvada Midget Football Association, Alameda Midget Football Association, Bear Creek Midget Football Association, Broomfield Football League, Englewood Youth Sports Association, Golden-Applewood Midget Football Association, Green Mountain Midget Football Association, Highland Ranch Youth Football Association, Lakewood Midget Football Association, Mountain Area Midget Football Association, North Metro Youth Football Association, South Jeffco Sports Association, South Metro Youth Sports, Wheat Ridge Area Midget Football Association, from any and all liabilities incident to my involvement or participation in these programs, EVEN IF ARISING FROM THEIR NEGLIGENCE, to the fullest extent permitted by law.

I HAVE READ THIS RELEASE OF LIABILITY AND ASSUMPTION OF RISK AGREEMENT, FULLY UNDERSTAND ITS TERMS, UNDERSTAND THAT I HAVE GIVEN UP SUBSTANTIAL RIGHTS BY SIGNING IT, AND SIGN IT FREELY AND VOLUNTARILY WITHOUT ANY INDUCEMENT.

- Current physical (must be of the current calendar year and dated before the first practice)
- Proof of residence (Xcel bill)
- Payment in full if not paying by credit card.

I understand my player will not be allowed to practice until the above items are turned in to the coach or team manager.

I understand that Jefferson County Midget Football has a minimum play rule. Each player in the league must play at least 15 plays per game.

Youth Tackle Football Program

Parent's Code of Ethics

I hereby pledge to provide positive support, care and encouragement for my child participating in youth sports by following this Parent's Code of Ethics Pledge.

I will encourage good sportsmanship by demonstrating positive support for all players, coaches, and officials at every game, practice or other youth sports events

I will place the emotional and physical well-being of my child ahead of a personal desire to win. I will be in control of my emotions.

I will remain in the spectator area during competitions.

I will insist that my child play in a safe and healthy environment.

I will support coaches and officials working with my child, in order to encourage a positive and enjoyable experience for all. I will not advise the coach on how to do the job.

I will demand a sports environment for my child that is free of drugs, tobacco and alcohol, and will refrain from their use at all youth sports events. I will not drink alcohol at a contest or come to one having drunk too much.

I will remember that the game is for our youth -not adults. Participation in youth sports is a privilege, not a right.

Please show respect for all participants at all times.

I will do my very best to make youth sports fun for my child. I will not instruct him to harm any other participants knowingly.

I will not coach my child during the contest.

I will ask my child to treat other players, coaches; fans and officials with respect regardless of race, sex, creed or ability .I will not make insulting comments to players, parents, officials, or coaches of either team.

I promise to help my child enjoy the youth sports experience by doing whatever I can,

such as being a respectable fan assisting with coaching or providing transportation. I will require that my child's coach be trained in the responsibilities of being a youth sport coach and that the coach upholds the Coaches Code of Ethics.

I will thank coaches, officials, and other volunteers who have conducted the event.

I understand that my responsibilities include setting an example for children and that any breach of those responsibilities will result in my inability to attend games or practices if deemed necessary by the program coordinators.

JMFA CODE OF CONDUCT: Each team shall be responsible for keeping the spectators orderly and off the playing field and behind the spectator's boundary. Shouting abusive language at a player, officials, or spectators is strictly prohibited, and a violation shall result in the enforcement of the high school rules. At the immediate time of any incident or physical abuse of an official by any spectator, the officials will meet with the head coaches of both teams in order that every effort is made to identify the assailant. Physical abuse of an official by a coach or parent will result in suspension of the coach from all JMFA activities for the entire calendar year or 365 days, commencing with the date of the infraction.

EJECTION: Any player, coach (head or assistant), or spectator who is ejected from a game by the officials, or causes a game to be forfeited due to unsportsmanlike conduct will automatically be suspended for the next game (scheduled, playoff, or carnation bowl) on the first offence. A second such offence will cause such player, coach, or spectator to be automatically suspended for the remainder of the season (playoffs and bowl games included). Any flagrant offence is cause for automatic removal from all JMFA football activities. No reimbursement will be given.
