CODE OF CONDUCT

Players, coaches, spectators and parents are to conduct themselves in a manner that "Honors the Game" and demonstrates respect to other players, coaches, officials and spectators. In participating in the Greene Turtle Invitational an individual assumes certain obligations and responsibilities of honesty and integrity. It is required those individuals associated with The Greene Turtle Invitational will conduct themselves in a manner that reflects a positive image and will bring credit to the sport of lacrosse, themselves, and their team. The Greene Turtle Invitational reserves the right to dismiss anyone from the tournament at any time for behavior that is deemed unacceptable.

PLAYERS

As a player, I understand that I must follow these rules to stay in good standing:

- 1) Respect the game, play fairly and follow its rules and regulations and show respect for authority.
- 2) Demonstrate good sportsmanship before, during and after all games, practices or related activities.
- 3) Be courteous and respectful to opposing teams, players, coaches and the officials.
- 4) Be modest when successful and be gracious in defeat.
- 5) Respect the privilege of the use of private and public facilities and refrain from the use of drugs, tobacco, alcohol and abusive language.

PARENTS / LEGAL GUARDIAN

As a parent/legal guardian, I recognize that parents/legal guardians are the most important role models for their children, and that sports help to develop a sense of teamwork, self-worth and sportsmanship. As such, I agree to abide by the following:

- 1) Encourage good sportsmanship by demonstrating positive support for all players, coaches, fans and officials at games and practices.
- 2) Place the well being of my child before any personal desire to win.
- 3) Advocate a sports environment that is free of drugs, tobacco, alcohol and abusive language, and refrain from their use during youth sporting events.
- 4) Encourage my child to play by the rules and respect the rights of other players, coaches, fans and officials.
- 5) Agree to allow the coaches to instruct my child during game and practice situations and will not interfere by offering additional instruction.
- 6) Recognize that coaches are willing to discuss my son or the coaching philosophies, but agree that discussions will take place at the appropriate time and place and never during a game or practice or in the presence of any players.

WAIVER AND RELEASE

As the parent/legal guardian and/or player participant as named below, I understand that practicing and playing competitive lacrosse includes ACTIVITIES THAT INVOLVE RISKS OF SERIOUS BODILY INJURY, INCLUDING PERMANENT DISABILITY, PARALYSIS, DEATH, AND POTENTIAL SOCIAL AND ECONOMIC LOSSES ("RISKS"). I FULLY ACCEPT AND ASSUME ALL SUCH RISKS AND ALL RESPONSIBILITIES FOR ALL LIABILITY, LOSSES, COSTS, AND DAMAGES resulting from participation in these activities. I HEREBY WAIVE, RELEASE, AND COVENANT NOT TO SUE McDonogh School, Andrew Hilgartner, The Greene Turtle Franchise Corporation, Podopac, Inc., William A Packo, Jr, Jill G Packo, any other employees or assistants of these entities, and any team coaches or assistant coaches and release them from ALL LIABILITY, LOSSES, COSTS AND DAMAGES, including liability as a result of any negligence, while the player participates in The Greene Turtle Invitational including transportation to and from related events. I will be financially responsible for any medical attention or cost of transportation needed in association with my child/self participation in The Greene Turtle Invitational, or resulting from an injury received while playing lacrosse or participating in related activities. My individual medical insurance shall be the insurance coverage for any medical treatment resulting from participation of these activities and I also confirm that the player participant is a full member of US Lacrosse, which includes certain applicable insurance coverage.

I HAVE READ, UNDERSTAND AND AGREE TO THE TERMS OF THE CODE OF CONDUCT AND TO THE TERMS OF THE WAIVER AND RELEASE AND UNDERSTAND THAT I GIVE UP SUBSTANTIAL RIGHTS;
