A. Section II - Who Is An Insured is amended to include as an additional insured:

1. Team members, managers, coaches, assistants, referees and officials, sponsors and other individuals participating in the official functions of the Named Insured.
2. The person(s) or organization(s) shown in the Schedule above, if any;

but only with respect to liability for "bodily injury", "property damage" and "personal and advertising injury" caused, in whole or in part, by your acts or omissions or the acts or omissions of those acting on your behalf in the performance of your ongoing operations in connection with your "sports activities".

However:

1. The insurance afforded to such additional insured only applies to the extent permitted by law; and
2. If coverage provided to the additional insured is required by a contract or agreement, the insurance afforded to such additional insured will not be broader than that which you are required by the contract or agreement to provide for such additional insured.

B. With respect to the insurance afforded to these additional insureds, the following is added to Section III - Limits Of Insurance:

If coverage provided to the additional insured is required by a contract or agreement, the most we will pay on behalf of the additional insured is the amount of insurance:

1. Required by the contract or agreement; or
2. Available under the applicable Limits of Insurance shown in the Declarations;

This endorsement shall not increase the applicable Limits of Insurance shown in the Declarations.

C. For the purposes of this endorsement, "sports activities" means the organization, promotion, administration and conduct of games, practices, tournaments and related activities of the Named Insured.

All other terms and conditions remain unchanged.


