

RASA Background Check Procedure

RASA has instituted the following background check procedure for all adults volunteering as coaches, assistant coaches, and for any activity that requires direct and routine contact with children participating in a RASA activity. The following three (3) items are required for all RASA volunteers:

- 1) Pennsylvania State Police Criminal History Record: This document can be obtained online at <https://epatch.state.pa.us/Home.jsp> (see sample below)
- 2) Pennsylvania Child Abuse History Clearance: This document can be obtained online at <https://www.compass.state.pa.us/CWIS/Public/Home> (see sample below)
- 3) A copy of your Driver's License showing your current address (must match the address on both of your background checks)

The online background checks are currently offered online for free. Criminal History and Child Abuse records are considered valid for 5 years. However, copies of all three (3) of these forms will need to be provided to RASA once a year, as outlined below.

- Before Spring Season – Copies of Criminal History, Child Abuse History, and Drivers License are required by all volunteers, regardless of when previously provided.
- Before Fall Season – Copies of Criminal History, Child Abuse History, and Drivers License are ONLY necessary if not provided before or during the Spring season of the same year.
- Before Clinics or Other RASA Activities – Copies of Criminal History, Child Abuse History, and Drivers License are ONLY necessary if not already provided since the start of the Spring season of the same year.

All volunteers must submit the three (3) documents before any RASA activities commence.
