

Privacy Statement of the Superior Mustangs Organization

The Superior Mustangs do NOT rent, sell, lend, distribute or otherwise provide lists or rosters, whether containing child or adult information, to 3rd parties, except as required by CCMFL rules. Explicitly, NO 3rd parties are provided private member information for commercial solicitation purposes.

The Superior Mustangs does NOT knowingly grant 3rd parties access to or otherwise distribute the Superior Mustangs databases, with the exception of the stated service provider.

The only 3rd party that has access to member information is a hosted service provider, League Athletics and is subject to a separate policy. The sole purpose of the service provider is to manage and host the Superior Mustangs web site and e-mail/SMS messaging system. The League Athletics privacy policy may be found at the following link:

The Superior Mustangs does NOT publicly share rosters. Only members of teams and site managers/administrators can see roster lists.

Any parent may choose to have theirs or their child's information deleted from the online roster system.

Users may elect to opt out of (e.g.: decline) global e-mail communications from the Superior Mustangs by clicking the "Unsubscribe" link at the bottom of an e-mail, responding to an e-mail with an unsubscribe request or requesting record deletion by the webmaster through the online contact form.

The online system does NOT offer selective opt-out of e-mail. The system recognizes only opt-in or opt-out as settings.

The Superior Mustangs does occasionally provide information on 3rd party businesses for the purpose of Mustang football fundraising, camps and sports organizations that may be of interest to the Mustang community through either the Superior Mustang web site or through outbound e-mail at the discretion of the board, President and/or webmaster. E-mail lists and online users are not shared with these 3rd parties.

The Superior Mustangs does NOT collect or solicit e-mail addresses or mobile phone numbers of players during the registration process as a matter of practice. Parents may opt to have their child's e-mail address entered into the system at their discretion.

The Superior Mustangs REFRAINS from posting identifiable images of children and or names in typewritten captions.
