



## ALTERNATE MEMBERSHIP AGREEMENT

I, \_\_\_\_\_, hereby accept membership in the **Triple Play All Star Baseball Club** organization (“**Triple Play All-Star**”) as an Alternate Player and agree to support the activities of the Triple Play All-Star baseball program and to fulfill the payment obligations. I understand that if I am delinquent in my payment(s), my child \_\_\_\_\_ will not be allowed to participate in practices, scrimmages or games. I also understand that this Agreement binds me to the fee that is due upon signing.

I agree that my participation and my child’s participation in the Triple Play All-Star activities, including but not limited to, baseball games, practices, and parent-sponsored events which may have food and alcoholic beverages served and transportation to and from such activities, shall not in any way cause liability to the organization, it’s Officers, Owners, Sponsors, Directors, Coaches, Members, and/or Volunteers. More specifically, I (for myself and on my child’s behalf) waive, release and forever discharge the Triple Play Batting Cages, it’s Officers, Owners, Sponsors, Directors, Coaches, Members, and/or Volunteers from any and all actions, claims and demands for, upon or by any reason of any damage, loss or injury resulting from my participation in any Triple Play All-Star function regardless of any alleged negligence on the part of the Triple Play All-Star, and it’s Officers, Owners, Sponsors, Directors, Coaches, Members, and/or Volunteers. I also agree to defend, indemnify and hold the Triple Play All-Star, it’s Officers, Owners, Sponsors, Directors, Coaches, Members, and/or Volunteers harmless from any and all claims, demands, liabilities, expenses (including attorney fees), losses, damages or judgments for personal injuries (including death resulting there from) and/or damages to property caused by, resulting from, arising out of or in any way related to my participation or my child’s participation in Triple Play All-Star function. I will allow Triple Play All-Star to register my child with the Amateur Athletic Association (AAU) as a condition of playing for the Triple Play All-Star Baseball Club.

We encourage each player to play on his town team. If a conflict should arise between a Triple Play All-Star practice and a town team event, we encourage the player to support his home team. However, we expect each player to be available for each Triple Play All-Star game, regardless of his town schedule. Alternate players are afforded the same skill sessions, practices, and equipment as the regular player. Participation in every game is not guaranteed for the alternate player. The alternate will attend games in uniform if and only if he is invited by the coach to play. Triple Play All-Star values all players and will allocated playing time at an average minimum of 3 innings per game. When attending a game the alternate player will be considered equal to a full time player and be allocated playing time in the game(s) as if he/she was a full member.
