_____ I delegate and assign the Berthoud Youth Athletic Association and any of its' board members, officers, staff, agents, employees, coaches, and volunteers the authority to seek emergency medical care for my child, should such care appear necessary during my child's participation in any league activity.

_____ In consideration of including my child or children in the BYAA activity, I and my spouse, heirs, legal representatives and assigns, voluntarily and knowingly waive any and all claims against, and release from any and all such claims, the Berthoud Youth Athletic Association and any of its' board members, officers, staff, agents, employees, coaches, and volunteers, which may arise from any activity directly or indirectly related to this sport or activity, whether such claims arise through the negligence of any person or entity named herein, or otherwise.

_____ Furthermore, for myself, my spouse, heirs, legal representatives and assigns, I agree not to prosecute or present any claim or suit against the Berthoud Youth Athletic Association and any of its' board members, officers, staff, agents, employees, coaches, and volunteers for any claim arising from any activity directly or indirectly related to this association and related activity. I also agree to indemnify and hold harmless the Berthoud Youth Athletic Association and any of its' board members, officers, staff, agents, employees, coaches, and volunteers for any and all liability, loss, and or damage, including costs and Attorney's fees, which I or my spouse, heirs, legal representatives and assigns may suffer as a result of my child's participation in this activity.
